### FIRST AMENDMENT TO THE SERVING SENIORS FOR MANAGING NON-CONGREGATE SENIOR SHELTER AGREEMENT

This First Amendment to the Non-Congregate Senior Shelter Agreement (First Amendment) is made and entered into by and between the City of San Diego (City) and Serving Seniors (Contractor), also referred to individually as "Party" and collectively as the "Parties."

#### **RECITALS**

- 1. City approved a non-profit certification on September 13, 2022 for managing a non-congregate senior shelter, resulting in a contract between the City and Contractor (Agreement), effective on November 10, 2022.
- 2. The Agreement may be amended by written agreement executed by duly authorized representatives of both Parties.
- 3. The Parties wish to amend the Agreement to modify the budget as described in Exhibit F to the Agreement for managing the non-congregate senior shelter.

#### **TERMS**

For each section of the Agreement, do the following:

1. The table in Exhibit F to the Agreement, "Budget for Non-Congregate Senior Shelter," is DELETED in its entirety and REPLACED as follows:

- 3. All provisions of the Agreement not addressed in this First Amendment remain in full force and effect.
