# **COUNCIL DISTRICT 2**

# **QUESTION:**

What types of inspections are done virtually?

# **RESPONSE:**

Virtual inspections, using the Microsoft Teams conferencing platform, will be conducted with customers at the job site and a City inspector reviewing qualified projects remotely. Here is a list of single-family, duplex and townhouse project types that are qualified for virtual inspections:

#### COUNCIL DISTRICT 5

#### **QUESTION:**

Why are fewer applicants applying for the Spaces as Places permits?

#### **RESPONSE:**

Approximately one hundred applications have been received for Spaces as Places permits. The City took a very business friendly approach to the enforcement of Temporary Outdoor Dining Operations (TOBO) and has been encouraging businesses to remove these expired encroachments, but did not proactively take enforcement actions on expired TOBOs to assist in economic recovery efforts. More recently, complaints about TOBOs have arisen and the City will now be proactively enforcing the removal of all TOBOs in order to comply with the Spaces as Places permitting requirements for use of the public right of way for private business. It is anticipated that another 50 applications might be received in 2023.

# **Economic Development Department**

#### **COUNCIL DISTRICT 8**

#### **QUESTION:**

The San Ysidro Chamber of Commerce has proposed to launch a 12-month pilot program to assist 100 small businesses to increase their clientele and revenue streams via on-line sales. The estimated cost for the complete implementation of this program is \$335,000. This program could really help the San Ysidro area achieve full recovery from the losses experienced during the pandemic. Could it be funded through the Small Business Enhancement program (SBEP)?

#### **RESPONSE:**

SBEP funds are allocated annually consistent with Council Policy 900-15 and the priorities of the Office of the Mayor. Should SBEP be fully funded, Capacity Building grants would be available in Fiscal Year 2024 for nonprofit applicants serving small businesses in under-resourced communities.

#### **QUESTION:**

In Fiscal Year 2023, the Logan Heights CDC was awarded just over \$100,000 to provide outreach, education, and technical assistance to street vendors through the Street Vendor Ordinance. Those funds were exhausted by the Logan Heights CDC by December 2022. Is the department considering the allocation of additional funds to the Logan Heights CDC to continue this work in Fiscal Year 2024?

#### **RESPONSE:**

The Fiscal Year 2023 funding was provided on a one-time basis to help with the roll out, and education and outreach of vendors to comply with the new Street Vending Ordinance. We do not plan to allocate resources for this purpose in Fiscal Year 2024. \$200,000 of ARPA funding was included in the Fiscal Year 2023 budget to contract with community-based organizations to provide sidewalk vending outreach and education. Should SBEP be fully funded in the coming fiscal year, Capacity Building grants would be available in Fiscal Year 2024 for nonprofit applicants serving small businesses in under-resourced communities including those that support street vending.

#### **QUESTION:**

What funding is included in the Fiscal Year 2024 Economic Development Department budget to contribute to the education, support and success of street vendors?

#### **RESPONSE:**

No funding has been proposed for this purpose in Fiscal Year 2024. Should SBEP be fully funded, Capacity Building grants could be available in Fiscal Year 2024 for nonprofit applicants serving small businesses in under-resourced communities including those that support street vending within the City of San Diego.

#### **QUESTION:**

The homelessness crisis has affected many businesses in communities like Logan Heights. Some businesses have just decided to leave the area because they could not continue to operate under the conditions caused by street encampments. Has the Economic Development Department worked with the Homeless Strategies and Solutions Department to assist local businesses impacted the most by this situation? Are there resources in this budget for that kind of assistance?

#### **RESPONSE:**

EDD recognizes the complexity around addressing the impacts of the homelessness crisis on small businesses. The Department uses a number of revenue sources to support local businesses in districts impacted by homelessness such as the Central Commercial Maintenance Assessment District. EDD has worked with the Homelessness Strategies and Solutions Department, and the Small Business Advisory Board, to produce educational materials (Attachments 1 & 2: Safety Resource Toolkit for Small Businesses in English & Spanish) to help direct businesses to the resources available to them when dealing with such impacts. The department provides a variety of resources using SBEP and other funds depending on individual business need.

# **Communications Department**

# **COUNCIL DISTRICT 5**

#### **QUESTION:**

What is the status of including the date on non-agenda public comment for the CityTV graphic?

#### **RESPONSE:**

CityTV has been looking for a long-term solution that works with our existing equipment and staffing. Our production switcher is in need of an upgrade, as the current system is beyond its service life. We are seeking solutions as the vendor of the system we'd like to purchase does not meet the City's procurement requirements for insurance thresholds.

We are looking at other systems that can meet the procurement requirements, but due to availability and the backed-up supply chain, we haven't yet found the right manufacturer. This process is what caused a delay in responding to the Councilmember's request from February regarding the on-air graphics.

While seeking solutions, our team can implement a new graphic for the Non-Agenda Public Comment to include the date. It does require a change in our process, and staff will need to be

trained. We have standard graphics for every City Council show that are pre-set, including the Non-Agenda Public Comment, and we have graphics that are customized, which include the date graphic. Prior to each City Council meeting, our team needs to update the graphics and have them reviewed to ensure accuracy on air. It's a little convoluted to explain, but we would love to offer Councilmember von Wilpert and her staff a tour of the studio and control room if she has availability and interest.

CityTV is currently operating with three team members. We have one vacancy that was filled on May 8 and we have another team member who is out on extended leave. Each live meeting is covered by a sole television director who manages the recording, audio, camera shots, switching and graphics, so we have been careful about changing work processes until we are back to regular staffing levels.

The Communications Director will contact the Council Office to extend an offer to tour our studio and control room in CCP and to meet our CityTV team. We would be honored to host the team from Council District 5 sometime soon.

# Safety Resource Toolkit for Small Businesses

The Small Business Advisory Board and Economic Development Department compiled resources that can better equip businesses to keep their employees and customers safe. These resources offer guidance on how an employee or business operator can approach quality of life issues related to the current homelessness crisis. The City of San Diego supports and values our small business communities and offers these resources to help businesses cope with current challenges.

Depending on the situation, you may consider referring to these 3 key resources.

- 1. **9-1-1:** For potentially dangerous situations in which an individual poses an immediate threat to themselves or others.
- 2. **Psychiatric Emergency Response Team (PERT):** If you contact 9-1-1, they have the capability of dispatching the PERT. This program consists of licensed behavioral health clinicians, law enforcement officers and paramedics.

- 3. **Mobile Crisis Response Team (MCRT):** If you witness an individual in need of mental health services, you can contact the County of San Diego's MCRT for licensed mental health clinicians, case managers, and peer support specialists who can respond to behavioral health crises calls that do not involve known threats of violence or medical emergencies.

# Is Someone Loitering or Sleeping in Front of Your Business?

We encourage you to use calm language and politely ask them to leave. If they refuse to leave or for potentially dangerous situations in which an individual poses an immediate threat to themselves or others, you are encouraged to contact **9-1-1**. For all other situations, you can call the non-emergency line: (619) 531-2000.

#### Has Someone Entered Your Business Exhibiting Disruptive Mental Health Behaviors?

We encourage you to use calm language and politely ask them to leave. However, safety is always the priority. If they refuse to leave and the situation escalates, contact 9-1-1 which can dispatch PERT. You may also consider contacting the **MCRT** at (888) 724-7240.

#### Has Someone Left Hazardous Waste Near Your Business?

If you find hazardous waste such as toxic substances, you may consider contacting the **Environmental Services Department** at (858) 694-7000.

La Ciudad de San Diego apoya y valora a nuestras comunidades de pequeños negocios y ofrece estos recursos para ayudar a las empresas enfrentar los desafíos actuales.

# Dependiendo de la situación, puede considerar estos 3 recursos clave.

- 1. **9-1-1:** Para situaciones potencialmente peligrosas en las que un individuo representa una amenaza inmediata para sí mismo o para otros.
- 2. **Psychiatric Emergency Response Team (PERT):** Equipo de Emergencias Psiquiátricas. Si se comunica con 9-1-1, ellos tienen la capacidad de enviar personal de PERT. Este programa está formado por médicos licenciados en salud del comportamiento, agentes del orden público y paramédicos.

Ellos tienen médicos clínicos de salud mental, administradores de casos y especialistas en apoyo que puedan responder a las llamadas de crisis de salud conductual que no involucren amenazas de violencia o emergencias médicas.
