SUBJECT: Fiscal Year 2024 Budget Review Committee Referral Responses for May 9, 2023

This memorandum provides responses and/or follow up information to unanswered questions asked at the Budget Review Committee meeting held on May 9, 2023. The responses are listed by department in the order they were reviewed by the Committee.

# Homelessness Strategies and Solutions (HSSD)

## **COUNCIL DISTRICT 8**

### **QUESTION:**

How many unhoused individuals leaving institutions, such as jail or hospitals, return to being unhoused? What can be done to prevent this?

### **RESPONSE:**

The Department is fully aware unhoused individuals leaving institutions return to being unhoused; however, HSSD does not collect data to account for how many. HSSD seeks to learn from partnering agencies (e.g., hospitals, jails) what data they might collect on unsheltered individuals discharging from institutions. For the region, the Homelessness Management Information System keeps record of the prior living situation, current living situation, and exit destination. Discharge planning from institutions is a known practice to prevent individuals leaving institutions to unhoused circumstances; notwithstanding, the region has limited capacity to meet the needs of these individuals. As the City works to enhance collaboration with other agencies and partners, there are opportunities to advocate for expanded capacity of long-term care facilities, substance abuse treatment facilities, and/or other appropriate residential settings as an alternative to discharges to the street. HSSD will work with the Regional Task Force to quantify this number.

In addition to the City-wide Street Outreach listed above, the City of San Diego Street Outreach Program also includes additional outreach initiatives with scopes of work (1) modified to intentionally focus on clients with higher acuity and medical disparities and (2) not assigned to a specific neighborhood within the city-wide coverage plan. These specialized teams prioritize individuals whose needs have not been met through traditional outreach efforts and whose barriers require a medical and targeted housing-focused approach. Assessing current outreach efforts, at both the program and system levels, opportunities were identified to strengthen the service delivery with these specialized teams to enhance outreach efforts. These teams include the Multi-Disciplinary Team (MDT), HealthCare In Action (HIA), Encampment Resolution Funding – National Alliance on Mental Illness (ERF-NAMI) and Encampment Resolution Funding – HIA (ERF-HIA)

# San Diego Housing Commission (SDHC)

# **COUNCIL DISTRICT 8**

### **QUESTION:**

Does the San Diego Housing Commission track exits from permanent supportive housing? How may evictions have taken place?

### **RESPONSE:**

SDHC participates in permanent supportive housing (PSH) through multiple programs, such as Continuum of Care-funded PSH, rental housing vouchers committed to PSH (tenant-based and project-based vouchers), and affordable rental housing properties that SDHC, including its nonprofit affiliate, Housing Development Partners, owns or manages. For each type of PSH, data are available related to people exiting PSH; however, data specifically about evictions from PSH are not readily available for rental housing voucher households or Continuum of Carefunded PSH. For PSH properties SDHC owns and/or manages, eviction data are available. Page 3
