ORAL COMMENTS

Following are the oral comments provided by members of the public, the City Council and the Consolidated Plan Advisory Board (CPAB) during the 3 public hearings for the Draft FY 2017 Annual Action Plan and Substantial Amendment. Where warranted, the response from staff follows the comment.

APRIL 13, 2016 – CONSOLIDATED PLAN ADVISORY BOARD (CPAB) MEETING

Staff presented the Draft FY 17 AAP and Substantial Amendment to the CPAB. No action was taken by the CPAB because of a lack of quorum at the meeting. No public comments were made or received.

APRIL 20, 2016 – PUBLIC SAFETY & LIVABLE NEIGHBORHOODS (PSLN) COUNCIL COMMITTEE

On April 20, 2016 the PSLN Committee forwarded the Draft FY 2017 AAP and Substantial Amendment to the full City Council with a recommendation to approve. No public comments were made or received.

APRIL 26, 2016 - CITY COUNCIL MEETING

Juan Del Rio (Submitted a speaker's slip in opposition)

• Mr. Del Rio questioned the recent placement of rocks to deter homeless on the intersection of Imperial Avenue and Commercial Street.



Margaret Cutchnia (Submitted a speaker's slip in opposition)

• Ms. Cutchnia questioned the recent placement of rocks to deter homeless on the intersection of Imperial Avenue and Commercial Street.

Jeannie Crescendo (Submitted a speaker's slip in opposition)

• Ms. Crescendo questioned the recent placement of rocks to deter homeless on the intersection of Imperial Avenue and Commercial Street.

Staff response: No action required. The three public comments above are not specific to the contents of the FY 2017 Annual Action Plan and Substantial Amendment.

Kathryn Rhodes (Submitted a speaker's slip in opposition)

• Ms. Rhodes would like to see more funding directed towards the San Diego Housing Commission's Affordable Housing Trust Fund to be used for homelessness.

Staff response: No action required. FY 2017 CDBG funds for homeless programs, as defined by Council Policy, and ESG funds, as specified in an existing Memorandum of Understanding between the City and the San Diego Housing Commission, were allocated by the City Council on March 22, 2016 and included in the FY 2017 Annual Action Plan, subsequently approved by City Council on April 26, 2016.

Rich Thesing, CPAB member (Submitted a speaker's slip in favor)

• Mr. Thesing requested the City Council approve the Action Plan and Substantial Amendment as presented.

Vicki Granowitz, CPAB Chair (Submitted a speaker's slip in favor)-3-33



- Ms. Granowitz requested the City Council approve the Action Plan and Substantial Amendment.
- Ms. Granowitz was satisfied the CPAB was able to integrate the Geographic Targeting Initiative into the scoring and will look forward to increasing the impact future years.
- Ms. Granowitz also stated the upcoming year will have a new Challenge Grant category which promoted new applicants to apply.
- Ms. Granowitz mentioned there is also a new anticipated Affordable Housing Revolving Loan Fund which will incorporate elements of the Climate Action Plan.
- Ms. Granowitz is concerned with the vacancies (3) currently on the CPAB. Ms. Granowitz requested the Council expedite the nomination process so the new Board members can be prepared for the next fiscal year applications.

Kenneth Malbrough, CPAB co-chair (Submitted a speaker's slip in favor)

• Mr. Malbrough requested the City Council approve the Action Plan and Substantial Amendment as presented. Mr. Malbrough would also like to see the vacancies filled on the CPAB.

Councilmember Todd Gloria

- Mr. Gloria asked if there has been an increase or decrease in the total amount of grant funding. Ms. Marano responded that HOME, HOPWA, and ESG received an increase and over the past year and CDBG received a slight decrease.
- Mr. Gloria indicated that he supports homeless funds going to permanent supportive housing initiatives – as those are proven to help solve homelessness. Staff confirmed the Affordable Housing Revolving Fund will have a focus on permanent supportive housing. Mr. Gloria expressed his support for the FY 2017 Annual Action Plan and Substantial Amendment.

Robert McNamara, (Submitted a speaker's slip in favor)

Mr. McNamara submitted a speaker slip in favor but did not speak.



David Ross, (Submitted a speaker's slip in favor)

Mr. Ross submitted a speaker slip in favor but did not speak.

Item was approved unanimously 8-0, with one Council member absent.

<u>Written Comments</u>

Ms. Martha Welch submitted a written comment requesting more funding go towards affordable housing and homeless services.

<u>Staff response</u>: No action required. FY 2017 CDBG funds for homeless programs, as defined by Council Policy, and ESG funds, as specified in an existing Memorandum of Understanding between the City and the San Diego Housing Commission, were allocated by the City Council on March 22, 2016 and included in the FY 2017 Annual Action Plan, subsequently approved by City Council on April 26, 2016.

Ms. Kathryn Rhodes submitted a letter dated April 20, 2016 via email to the City's Economic Development Department. The letter contains groups of questions that have been copied below and also includes supporting documentation. The staff response follows each related group of questions. A complete copy of the letter is incorporated at the end of this section.

Although Ms. Rhodes indicates in the introduction of her letter that "since 2009, we have given feedback and turned in public comments for the Federal Housing and Urban Development's (HUD) Annual Action Plans (AAP)...However, so far my outstanding 7-year old questions have never been addressed or answered," please see the links below to the most recent FY 2015 CAPER and FY 2016 Annual Action Plan which include responses to Ms. Rhodes questions.

Question 1: The AAP and Substantial Amendment to the Consolidated Plan reports should be revised to document the DOF's approval made 6 days before the April 20, 2016 PSLN-6 hearing. Although the DOF approval was made, this new information



was not part of the draft report. Please update this report with current information before sending the final report to HUD. *(Referencing CDBG repayments of \$10,912,000 and \$8,000,000)*

<u>Staff response</u>: No action required. In FY 2017, \$10.9 million in CDBG program income will be received as the result of the approval ROPS 10. The FY 2017 Annual Action Plan includes the allocation of the these program income funds and the methodology for distributing these additional Program Income funds is described in the Substantial Amendment to the FY 2015 – FY 2019. The \$8,000,000 line item approved in ROPS 10 has not yet been confirmed as CDBG Program Income. If and/or when it is confirmed to be CDBG Program Income, or a portion of it is confirmed to be CDBG Program Income, it will be allocated in FY 2018 pursuant to a subsequent Substantial Amendment to the Con Plan and will be detailed in the FY 2018 Action Plan.

Question 2: What is the amount of any LMIHAF excess surplus Cash Reserve Fund Balances, the amount of time the excess surplus existed, and the Housing Successor Entity's (HSE) plan for eliminating the excess surplus? What specific projects will be funding using the \$286.1 million in LMIHAF assets, including \$28.7 million in Cash Balances identified in the FY-2015 Comprehensive Annual Financial Report (CAFR)? How much Negative Arbitrage costs have been accumulated since 2010 on SA and SHE LMIHAF Housing Bonds? Have all the SA/LMIHAF Bonds been refunded? Why not? What are Civic San Diego plans to spend all Reserve and Other Funds Accounts so additional SA/LMIHAF will not be lost in subsequent ROPS periods by default at a rate of 17.5 cents on the dollar to the City's General Fund? If the SDHC is in charge of Homeless services, why is the LMIHAF controlled by the private non-profit Civic San Diego staff instead of San Diego Housing Authority (SDHC) staff? What are the benefits for two duplicate Administrations for Affordable Housing and Homeless issues between the SDHC and Civic San Diego? Is this a Best Practice or just Politics? Should the \$286.1 million in LMIHAF assets controlled by private Civic San Diego staff be moved into a Special Revenue Fund within the Housing Trust Fund (HTF) controlled by the SDHC for immediate use for the Homeless?

Question 3: When the issue of Homeless Emergency Shelter and Services is Ministerial with the Shelter Crisis announcement, why are Discretionary CUPs through CEQA still required by staff? Does the Homeless Emergency Shelter Crisis get rid of the need for CUPs on public and/or private property? What is the City Attorney's legal opinion on the matter?

<u>Staff response</u>: No action required. These questions are not specific to the contents of the FY 2017 Annual Action Plan and Substantial Amendment.

Question 4: Why has the City failed to enforce the 1992 Agreement for Cooperation between the City Successor Agency (SA) and the County for annual \$23,716,972 (FY-2016) in Tax Sharing payments for the six vulnerable populations including children, seniors, mentally ill, drug and alcohol treatment? Since 1992, how much money in RDA and SA Tax Sharing allocations has been collected by the County? How much cash in Tax Sharing Payments have been used for the 6 identified vulnerable populations? Where is the required annual plans from Civic San Diego for use of 40% of the County's Tax Sharing Payments?

<u>Staff response</u>: No action required. These questions are not specific to the contents of the FY 2017 Annual Action Plan and Substantial Amendment.

What is the holdup by the SDHC to using HUD HOME TBRA immediately?

<u>Staff response</u>: No action required. These questions are not specific to the contents of the FY 2017 Annual Action Plan and Substantial Amendment.

Housing through SVDP's Paul Mirabel Center (PMC)? State law allows CALTRANS to lease air rights to the Neil Good Day Center (NGDC) for Homeless services. The City is in the process of NGDC rehabilitation with plans to create transform the building to a new Police substation. By what authorization and law does the city think they can kick out the homeless from the NGDC for city functions unrelated to serving the Homeless?

<u>Staff response</u>: No action required. These questions are not specific to the contents of the FY 2017 Annual Action Plan and Substantial Amendment.

Question 7: On February 4, 2016, the California Department of Housing and Community Development (HCD) issued Information Bulletin 2016-01 to City and County Building Officials on approval procedures for Tiny Home construction including Park Trailers, and Camping Cabins without plumbing. When will the City incorporated Information Bulletin 2016-01 into the Municipal Code to allow Homeless to be housed in Tiny Homes throughout San Diego?
