EXECUTIVE SUMMARY OF ITEM:

On October 9th, 2019, Assembly Bill 116 was passed to amend existing Enhanced Infrastructure Financing District laws. This amendment to the Government Code included a requirement that the Public Finance Authority adopt an Annual Report as set forth in Government Code section 53398.66(j)(3). The Planning Department, in conjunction with other supporting City of San Diego departments, has prepared the District's Fiscal Year 2019 Annual Report (Attachment 1).


A draft report was made available to the public on the EIFD's website on May 7, 2020, which was more than 30 days before the public hearing. In addition, a written notice was mailed to all residents and owners of land within the area covered by the District.

In order to comply with the newly established requirements, the District's Fiscal Year 2019 Annual Report includes the following sections:

Description of the projects undertaken in the fiscal year

The La Media Road Improvements (S-15018) project was the only project with activity during Fiscal Year 2019.

A chart comparing actual revenues and expenses



Fiscal Year 2019 concluded with revenues of \$571,445, 14.7% less than the budget amount of \$670,000. Operating expenditures ended the fiscal year at \$145,017, 51.8% less than the budget amount of \$300,952.

Amount of tax increment revenues received

A total of \$571,445 of tax increment revenues was received.

Assessment of the status of the District's projects

The La Media Road Improvements (S-15018) project was the only active District project during Fiscal year 2019. Work continued on the design and environmental phase of the project.

Amount of revenues expended to assist private business

No Fiscal Year 2019 revenues were expended to assist private businesses.

CONCLUSION:

The Fiscal Year 2019 fiscal activity for the District has been audited and the limited tests on internal controls did not reveal any material misstatements or noncompliance. It is recommended that the Authority adopt the District's Fiscal Year 2019 Annual Report.
