The City of San Diego accepted statements of qualifications from October 2, 2017, to November 3, 2017, from organizations interested in applying for CDBG funds for projects beginning implementation on July 1, 2018. The Request for Qualifications (RFQ) was the first phase of the application process. Organizations that did not submit their qualifications by the deadline, or were subsequently deemed “not qualified” through the RFQ process, are precluded from submitting project proposals in January 2018 for Fiscal Year 2019 CDBG funding consideration.
