Public Comments

The City will consider comments and views expressed by residents, public agencies, and other interested parties either in writing or orally at public meetings. In each 5-Year Consolidated Plan, Annual Action Plan, CAPER, substantial amendment or Citizen Participation Plan submitted to the U.S. Department of Housing and Urban Development (HUD), the City will provide as an attachment all written communications received and a summary of each oral comment during the applicable 30-day public review period; the City's subsequent action; and the reasons for non-action, if none was taken. This information will also be made available to the public as part of the final document.

Following are the questions and comments received on the Draft Fiscal Year (FY) 2023 Annual Action Plan (AAP). Responses were provided by staff, where warranted. The Draft FY 2023 AAP was made available for public review from April 1 through April 30, 2022. Public Comments and Staff Responses

Following are the oral comments provided by members of the public, the City Council and the Consolidated Plan Advisory Board (CPAB) during the three public meetings for the Draft FY 2023 Annual Action Plan. Where warranted, the response from staff follows the comment.

April 7, 2022 - Public Safety & Livable Neighborhood (PSLN) Committee Meeting

On April 7, 2022, the PSLN Committee forwarded the FY 2023 Annual Action Plan to the City Council with a recommendation to approve.

Office of the Independent Budget Analyst

Erin Noel, Fiscal and Policy Analyst, said the office had no specific concerns about moving the item forward. The FY 23 Annual Action Plan includes budgets for three HUD entitlement programs – HOME, ESG, CDBG. HOME and ESG funds are administered by the SDHC, and CDBG is administered by City.

IBA staff recommended that the PSLN committee may want to request more frequent updates from Economic Development Department (EDD) staff to provide information on the programs, projects, and available funding. Regarding CDBG infrastructure projects, while recommended projects are usually reviewed and approved by the Capital Improvements Program Review and Advisory Committee (CIPRAC), this did not occur this year due to time constraints and the cancellation of CIPRAC meetings. EDD staff told the office of IBA that they fully reviewed projects to ensure they meet HUD requirements and vetted the projects with Asset Managing Departments. In future years, the plan is to have these projects reviewed by CIPRAC or its subcommittee.

Regarding the waiving of requirements in Council Policy 700-02, EDD Staff said this was approved in FY 22 and it was beneficial to address challenges related to the COVID-19 pandemic. Many of these challenges are still ongoing, which is why staff are requesting this in FY 23.

Regarding homelessness, this item continues funding for programs supported last year, including the Family Shelter. The Family Shelter is still waiting for a site to be identified to continue the program, since it was previously operated out of the SMART (Palm Avenue) facility.

This item proposes two separate NOFA processes for the development of affordable housing, which was established last year. One process is run by the City and which incorporates CDBG funds, other is run by the San Diego Housing Commission (SDHC), which incorporates HOME funds.

Councilmember comments

Councilmember Vivian Moreno, District 8

Councilmember Moreno thanked EDD staff for the presentation. She stated that she is thrilled to see community parks being funded in her district. She commented she was happy to see the Affordable Housing NOFA receive \$8 million in CDBG funding. Councilmember Moreno agreed with the IBA that this should be an item that is brought forward in a few months to receive updates on the status of the NOFA, and CDBG funding.

Councilmember Marni von Wilpert, District 5

Councilmember von Wilpert asked when then Affordable Housing NOFA would be released.

Staff Response: Angela Nazareno Clark, HUD Program Manager, responded that once the City receives a confirmation from HUD on the entitlement amount, there will be better estimate on the timeline of the NOFA release.

Councilmember von Wilpert asked for confirmation that the \$500,000 Homelessness Program funding would be used for the Day Center, and how specifically funding would be used.

Staff response: Ms. Nazareno Clark confirmed the \$541,250 amount is for the Day Center and that the funding would be used for operations and services provided in 2023.

Lisa Jones, Executive Vice President at the San Diego Housing Commission reiterated that the funding would be used for this is for ongoing operations, for example, staff. Additionally, the City set aside some funding for rehabilitation at this site. The lease is still in negotiations with Caltrans, but once that has been finalized, the rehabilitation work will begin. There is a contract with Father Joe's that allows for showers at the Father Joe's campus. 14,000 showers were provided at the Father's Joes campus since last July.

Councilmember von Wilpert asked whether the Family Shelter program was located at Golden Hall or Palm Avenue.

Staff response: Lisa Jones responded that the program was located at Palm Avenue but has ended. The City of San Diego's Homeless Strategies and Solutions department is actively looking into a new site to operate the same program.

Councilmember von Wilpert asked how Councilmembers could check how these allocations of HUD funding for homelessness programs are assisting the City in meeting its Strategic Plan goals for homelessness.

Staff response: Lisa Jones responded that the SDHC will work with EDD staff to provide linkages to these goals.

Councilmember von Wilpert asked for more information on the First Time Homebuyer Program and previous outcomes for the program.

Staff response: Liliana Caracoza, Housing Program Analyst at SDHC, responded that the program provides down payment assistance to first time homebuyers. Previously, down payment assistance was 17% but was now raised to up to 22% due to increasing housing costs. Additionally, the program provides a forgivable closing cost grant. The program is available throughout the city. Last year, HOME allocation for this program was \$2,000,000 and about 26 households were supported. The average assistance amount was \$100,000. Due to the current housing market, the amount of assistance is larger, however, less households are assisted.

Councilmember Raul Campillo

Councilmember Campillo thanked staff and was happy to move staff recommendations. He stated that he was excited to see CDBG funds allocated to strong community partners within District 7, such as Kitchens for Good and the Bayside Community Center. He also highlighted Voices for Children, an organization that provides foster children with Court-Appointed Special Advocates (CASA) who advocate on their behalf.

Council President Pro Tem Monica Montgomery Steppe

Council President Pro Tem Montgomery Steppe thanked EDD staff and CPAB for going through the application process. She agreed with previous comments that more updates to the PSLN committee, for example around the Affordable Housing NOFA and how HUD funding helps the City meets its goals in the Homelessness Action Plan. Councilmember Montgomery Steppe asked, with regards to CIPRAC meetings being suspended if there was an effort made by staff to go through a process with the CIPRAC subcommittee.

Staff Response: Ms. Nazareno Clark confirmed that yes, the City Capital Investment Projects (CIPs), were reviewed by the CIPRAC Subcommittee, as an informational item on March 29, 2022.

Krissy Maier, Community Development Coordinator, added that staff have been working closely with the Engineering and Capital Projects for several months, where CIPRAC is housed. Ms. Maier reiterated that this effort to work with CIPRAC will be continued to be staff process and goal.

Councilmember Montgomery Steppe asked about a timeline for changes in NOFA funding due to changes in HUD allocations.

Staff response: Ms. Nazareno Clark responded that HUD has until May 15 to confirm the City's entitlement amount. If the amount is lower than anticipated, less funding will go wards the Affordable Housing NOFA. Staff will update councilmembers when the amount is confirmed.

Economic Development Deputy Director Monica Hardman added that staff are in the process of bringing Round One NOFA projects to City Council for approval. Staff received the first recommendation, Cortez Hill, a couple of weeks ago. The first round of Affordable Housing NOFA,

\$33,000,000 was available from three different funding sources: CDBG, Low-Moderate Income Housing Asset Fund, and Permanent Local Housing Allocation. The second round of the Affordable Housing NOFA is comprised of CDBG and Permanent Local Housing Allocation Funds. With the second round of Affordable Housing NOFA, staff will continue to review and recommend projects received in the first allocation. Staff anticipate to have \$20,000,000 available for the second NOFA round.

Councilmember Montgomery Steppe commented that the work the City does with nonprofits in building capacity and partnerships in partnership with USD is important, and that CDBG funding is sometimes difficult for organizations to be awarded with. She asked whether there were resources organizations can access and if they are working on capacity building for their nonprofits.

Staff response: Michele Marano, Community Development Coordinator responded that the CDBG website has a checklist for organizations to refer to find funding programs within the City. Regarding the Nonprofit Academy at the University of San Diego, it has been placed on pause for approximately a year, but the department is exploring restarting the program. Finally, staff are listening to Councilmember's Montgomery Steppe's request to repackage outreach and technical assistance opportunities to nonprofit organizations.

Councilmember Montgomery Steppe commented she values programs that introduce youth to the City to potentially create a career pathway for them, especially with the many vacant positions at the City. She commented that she understood that CDBG is not the only funding source but wanted to highlight that the Connect2Careers program from the San Diego Workforce Partnership is a priority for her.

Staff response: Christina Bibler, Director of the Economic Development Department, responded that the department shares similar sentiments and it is an important time to underscore the pipeline the City needs for workforce development. She added that the department had allocated funding from its General Funds budget to support the Connect2Careers program.

Response from Mayor's office: Matt Yagyagan, Deputy Director of Policy added that the Mayor's Office has applied for funding from the state in the amount of \$19,000,000 to put out some workforce development programming, including opportunities here at the City. They are working on implementing the program and would provide a briefing to members of the committee once details are finalized.

Consolidated Plan Advisory Board Meeting on April 13, 2022

No public comments were made. The CPAB recommended the Draft FY 2023 Annual Action Plan to City Council.

City Council meeting on April 26, 2022

Please note: due to the prior council meeting running longer, Councilmembers requested the presentation be waived so staff answered questions from councilmembers.

Public Comments

David Oddo, a long-term advocate for poor and disenfranchised people and member of the Linda Vista community planning group, spoke in opposition of the FY 23 Annual Action Plan. He stated that the City of San Diego does not appear to be meeting its obligations to take meaningful actions to affirmatively further fair housing. He commented that there is evidence of possible mortgage lending discrimination which is an impediment to fair housing choice and there have been no meaningful steps taken to remedy this. He has communicated concerns to City staff and has one copy of evidence of fair housing discrimination in city of San Diego to share with councilmembers.

Kelly Douglas, CEO of Voices for Children spoke in favor of the FY 23 Annual Action Plan. She thanked the City of San Diego for their support and consideration of their application for CDBG funding. Voices for Children serves San Diego's children in foster care from birth to age 21 by supporting them through the advocacy of special volunteers called "CASA", or Court-Appointed Special Advocates. Ms. Douglas thanked the City for the generous grant and stated that the organization will be able to provide advocacy for a year to about 30 children.

Joy Cinata from District 3 thanked Christina Bibler and staff for the detailed information provided. She asked about the Point-in-Time Count figures and stated that she has not seen the numbers yet. She asked where they can be found and whether they needed to be reported in the Annual Action Plan. She also commented that the Emergency Service Grants (ESG) will be funding two great programs. Finally, she presented a caution on the waivers requested by staff for Council Policy 700-02. She requested that workshops are not eliminated as they are extremely important and should be kept as a requirement.

Staff note: Please note, the Point-in-Time Count is conducted by the Regional Task Force and the data for the latest count was completed after the Council hearing. The report can be found at <u>this link</u>.

Catherine Rhodes commented that the City is receiving \$15,000,000 from the HUD OIG Audit Debt Repayment to the CDBG program income. HUD's audit showed that there was at least \$214,000,000 that the City took and needs to return to poor communities, with interest. She commented that instead of \$15,000,000, councilmembers should request \$50,000,000 if there is money available for it. Since 2010, there is supposed to be accrued interest on the \$214,000,000 in OIG audit debt repayment to CDBG program income. The accrued interest amount, across 13 years would total approximately \$400,000,000 that could go to low income neighborhoods in the City of San Diego.

Councilmember Comments

Council President Pro Tem Monica Montgomery Steppe, District 4, commented that she appreciated staff being available and responsive to applicant questions and providing technical assistance and one-on-one meetings. She said she hoped to work with staff to expand that and outreach efforts so more organizations are aware of these opportunities. She also commented that she appreciated the Economic Development department's dedication to the Connect2Careers program, which creates pathways for young people in low-to-moderate income neighborhoods.

Councilmember Vivien Moreno, District 8 thanked staff for their work on this item. She said she was happy to see Beyer Park and Eggers Park in District 8 to receive funding through this item.

Councilmember Stephen Whitburn, District 3, stated that he supported this item. He stated that the number one priority is finding solutions to homelessness in the City -- the current state of homelessness is unacceptable we need to do everything in our power to provide more shelter beds and find opportunities to help revive rapid rehousing for our unsheltered population. He commented that we also need to provide short-term housing opportunities immediately to get people off the street and out of encampments. He was happy to see a total of more than \$3,700,000 allocated in CDBG programs and projects that are expected to assist over 6,000 individuals and households within District 3. He was also happy to see that the funding recommendations also include Family Health Centers Safe point San Diego program, and the LGBT Community Center's Behavioral Health Program.

Councilmember Joe LaCava, District 1, thanked the Consolidated Plan Advisory for their service and good work.

Council President Sean Elo-Rivera, District 9, commented that he was glad to see continued investments be made in low-to-moderate income communities. He stated he is particularly interested in investments in the Bridge to Home program, which he believes to be a very important investment. Honorable Members of the San Diego City Council;

I am opposed to this proposed resolution because, according to my research, the City of San Diego does not appear to be meeting its legal obligation (i.e. certification) to "Affirmatively Further Fair Housing" practices.

Although I am not an attorney, I have been able to obtain evidence of possible mortgage lending discrimination in the City of San Diego. The document in question is titled "Testing Project: Legal Aid Society of San Diego FY 2012- 2013." Legal Aid is the agency contracted with the City to provide fair housing services. (See attached summary report.)

According to the United States Department of Justice, fair housing testing is a valuable tool with regard to documenting illegal discrimination. (www.justice.gov)

The relevant section of the aforementioned fair housing audit is as follows: Of ten paired undercover tests at area lending institutions (each test consisting of one potential white homebuyer couple and one potential homebuyer African American couple), African American couples experienced discriminatory treatment in 60% of these tests. A previous fair-lending audit produced similar results, and is documented in the 2005-2010 San Diego County Analysis of Impediments to Fair Housing Choice.

Unfortunately, the City of San Diego has apparently failed to take meaningful actions (such as a follow-up fair lending audit) to overcome this important barrier to fair housing choice. Inexplicably, the aforementioned discriminatory results are not even mentioned as an impediment to fair housing choice in the City's CDBG documents, as well as the 2021-2025 San Diego Regional Analysis of Impediments to Fair Housing Choice.

In my opinion, such inaction over a period of many years severely restricts access to opportunity. And it calls into question the City's commitment to the concept of fair housing. Therefore, I cannot support the City's efforts to obtain HUD-sponsored funds for community development. I am also considering reporting these possible fair housing violations to the Department of Housing and Urban Development's Office of Fair Housing and Equal Opportunity. Thank you for your consideration.

Staff response: Thank you for your interest in the City's Practice Fair Housing Program. As you know, the City is required to affirmatively further fair housing (AFFH). HUD defines AFFH as taking "significant actions that are designed and can be reasonably expected to achieve a material positive change that affirmatively furthers fair housing by, for example, increasing fair housing choice or decreasing disparities in access to opportunity."

Every five years the jurisdictions in the San Diego region (including the County of San Diego, the City of San Diego and 17 other municipalities) work together to conduct an Analysis of Impediments to Fair Housing Choice (AI) report. The most recent AI is available on the City's website at <u>https://www.sandiego.gov/sites/default/files/fhaifinal2020.pdf</u>. Please see pages 120 – 131 for a detailed analysis regarding lending practices. As stated in the AI, "...publicly available data on lending does not contain the detailed information necessary to make conclusive statements of discrimination, but it can point out potential areas of concern. Furthermore, except for outreach and education efforts, local jurisdictions' ability to influence lending practices is limited. Such practices are largely governed by national policies and regulations."

The AI identifies impediments that may prevent equal housing access and develops solutions to mitigate or remove such impediments. One of the impediments identified on page 195 is the ongoing underrepresentation of Blacks and Hispanics in the homebuyer market and the large disparities in home loan approval rates.

Based on the AI recommendations, the City develops a plan to mitigate the impediments listed in the AI. The accomplishments towards the goals are reported in the annual CAPER. The 2021 report of accomplishments is located <u>https://www.sandiego.gov/sites/default/files/cosdfy21caper_att4.pdf</u>.

The annual CAPER report which includes the Fair Housing AI progress is submitted annually to HUD for review, comment, and approval. To date, the City has complied with requirements to affirmatively further fair housing.

Economic Development Funding Opportunities
