SUBJECT: Annual Evaluation and Report for Fiscal Year 2021 Citywide Grant Activities

This memorandum contains the Annual Evaluation and Report for Fiscal Year 2021 (FY 21) on City of San Diego grant related activities, pursuant to San Diego Municipal Code §22.5205:

Within 90 days of the end of each fiscal year, the City Manager shall provide Council with a written report of all initial grant applications and renewal requests that were accepted, appropriated, and expended by the City Manager during that fiscal year.

Background

In May of 2019, the City implemented recommendations from a performance audit with the goal of strengthening its grant operations, making more efficient use of City resources, and securing additional grant awards by the City. The citywide grants management function was consolidated under the Grants Division of the Department of Government Affairs within the Mayor's Office. Since that time, the department has improved several key processes related to grant activities, strategic alignment, internal review, training, tracking, and reporting.

The Grants Division works closely with the Department of Finance and all grant-active departments to ensure that submitted grant applications are properly vetted and approved by the applicable Deputy Chief Operating Officer, and the Chief Operating Officer. To date, the division has implemented the following process enhancements:

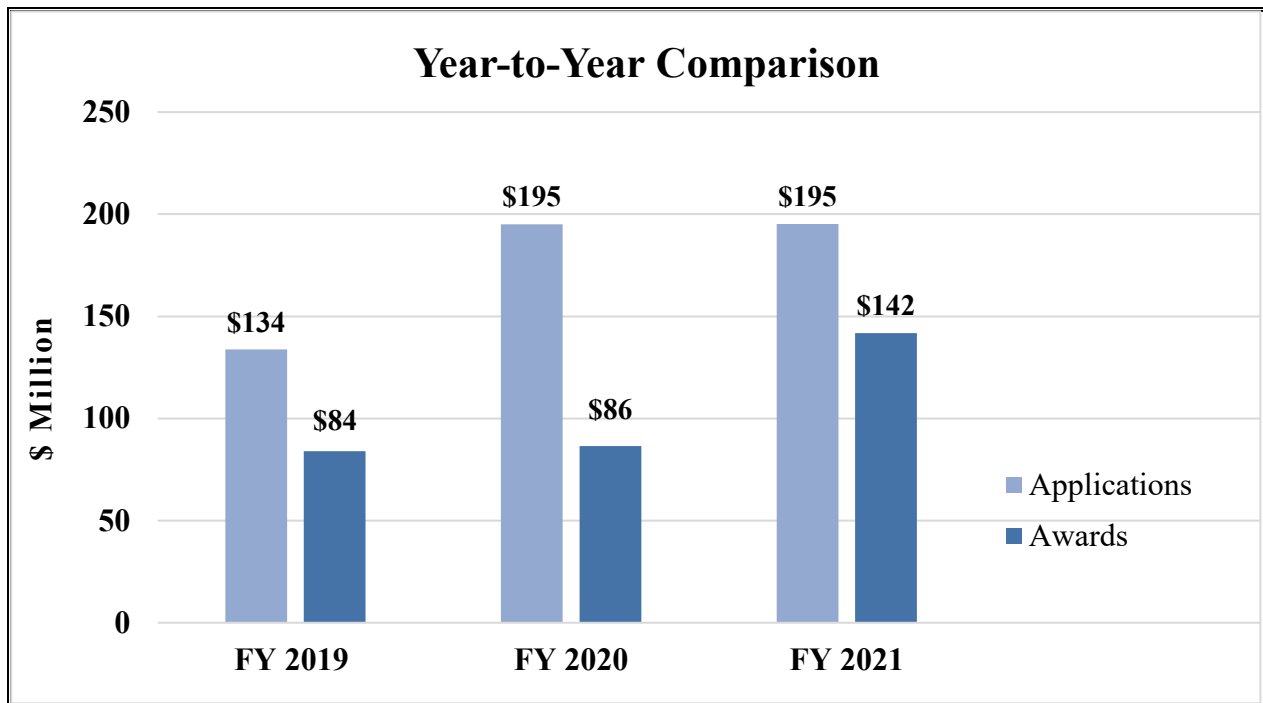
- Streamlined communication with stakeholders on State, Federal and private funding opportunities.
- Automated the approval system for all grant applications submitted by the City resulting in improved coordination, more robust internal controls, and greater fiscal accountability.
- Established points of contact among department staff for technical assistance, and engagement with regional agencies and elected representatives to obtain support for City applications.
- Improved comprehensive reporting processes on all citywide grant applications and awards.
- Formed an interdepartmental working group comprised of grant-active City department staff.

Overview

This year’s report illustrates that both the number of citywide grant applications and awards, as well as the amounts applied for and awarded, have increased year-over-year. For FY 21, the City of San Diego submitted a total of 79 grant applications with a combined value of \$195,272,703. The City was awarded a total of 55 grant awards with a combined value of \$141,713,026. For purposes of this section, COVID-19 pandemic related grants are not included and are covered in a separate section. Not all awards contained in this report were applied for in FY 21, and multi-year grants awarded in previous fiscal years are distributed to the City annually until the end of their grant terms. Individual applications and awards are included in Attachments 1 and 2.

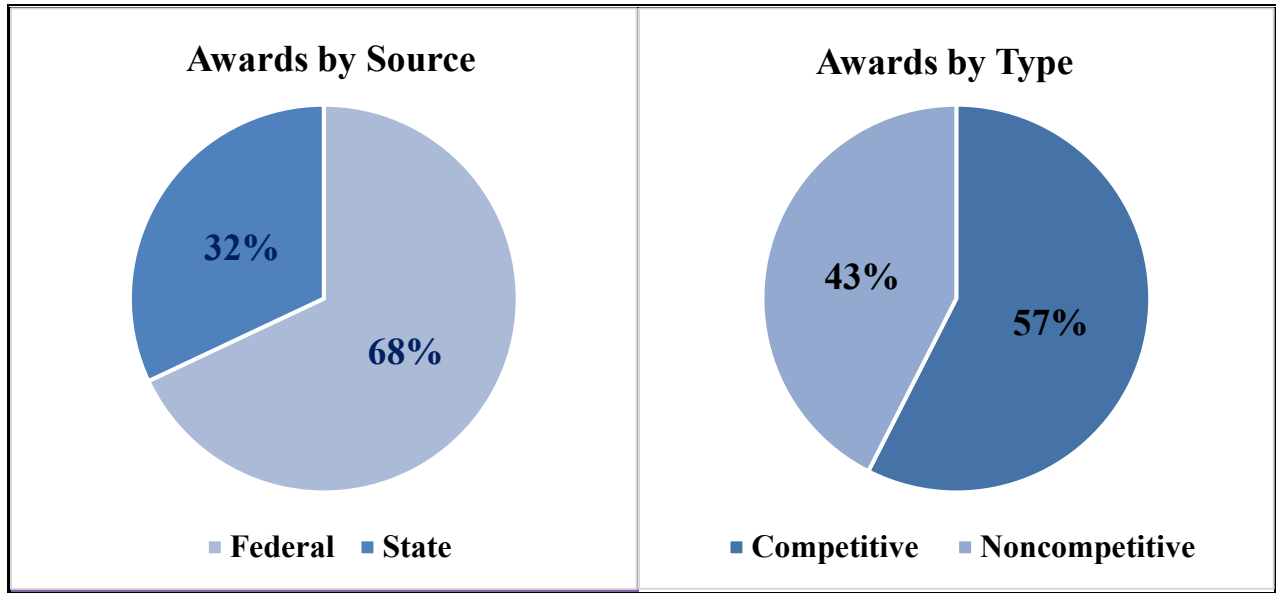
As compared to last year, FY 21’s total number of submitted applications increased by 5 (6.8%), and the total number of awards received increased by 10, (22.2%). This represents an increase of \$185,896 (.1%) in applications, and \$56,337,246 (63.8%) in awards.



This funding increase is primarily due to the following FY 21 awards:

Consistent with previous years, the City received approximately twice as much grant funding from Federal sources than from State agencies, with less than 1% of awards coming from the County and private organizations. Also, like previous years, the City received approximately 14% more competitive grant awards than non-competitive, or formula-based, allocations.



COVID-19 Recovery Assistance

Due to the unprecedented challenges of the COVID-19 pandemic that continued throughout FY 21, the Government Affairs Department worked with grants staff within individual departments to successfully secure numerous competitive and formula-based emergency pandemic-related grants from state and federal sources in support of essential City functions. Most notably, the City received a direct allocation of \$299,714,755 in American Rescue Plan Act (ARPA) Coronavirus State and Local Fiscal Recovery Funds from the U.S. Department of Treasury. Other pandemic-related supplemental funding that the City received through application or direct allocation is included in Attachment 3, for a total of \$459,301,779.
