Background

Budget Priorities Resolution is Council's first step in the budget process

- This is the first time the Resolution has been prepared in the fall.
 - Initial budget priorities were approved by City Council on November 1, 2022.
- This change in the budget process was implemented by City Council action on June 27, 2022.
 - Typically, Budget Priorities Resolution was adopted by Council in February, after a significant portion of the Mayor's Proposed Budget had been finalized.
- This change is intended to better position Councilmember priorities for consideration in the Mayor's Proposed Budget.
- Now City Council has an additional opportunity to update priorities.

Background

Budget Priorities Resolution is Council's first step in the budget process *(con't)*

- Updates to Councilmembers' priorities were submitted to our Office on January 13, 2023.
- IBA Report 23-02 summarizes updated budget priorities.
- Updated Budget Priorities Resolution will be submitted to Mayor after approval by City Council.

City Council Budget Resource and Mitigation Priorities

FY 2024 Resources Mentions:

- Federal American Rescue Plan Act (ARPA) (*one-time resource*)
 - Current estimate: \$52.1M available for FY 2024
- Use of Excess Equity or General Fund Reserve (*one-time resource*)
 - Excess Equity estimate at First Quarter Budget Monitoring: \$72.1M
- Grant opportunities being monitored (*fiscal estimates unavailable*)
 - Federal Infrastructure Investment and Jobs Act (IIJA)
 - California Child Care and Development Infrastructure Grant Program
 - Federal Inflation Reduction Act (IRA)
