Coastal Development Permit and Tentative Map for the demolition of two single family dwelling units and detached garage for the construction of three residential condominiums units. As a component of the application, the project incorporates a roof-mounted photovoltaic system consisting of solar panels sufficient to generate at least 50-percent of the project's projected energy consumption, in conformance with the criteria of the Affordable/In-Fill Housing and Sustainable Buildings Expedite Program. 0.14-acre site is located at 4105-4109 Haines Street in the RM-2-5 zone within the Pacific Beach Community Plan and Local Coastal Program area, Coastal Height Limitation Overlay Zone, Coastal Overlay Zone (Non-Appealable), Coastal Parking Impact Overlay Zone, and the Residential Tandem Parking Overlay Zone. The project site is designated for multi-family residential development (15-30 dwelling units per acre) in the Pacific Beach Community Plan and Local Coastal Program. The project application was filed on October 5, 2015. Exempt from Environmental. Report No. HO-16-076.
