On the webform, members of the public should select Human Relations Commission (even if the public comment is for a Human Relations Commission sub-committee meeting).

The public may attend a meeting when scheduled by following the attendee meeting link provided below.

Only comments submitted no later than 4pm the day prior to the meeting using the public comment webform will be eligible to be read into the record. If you submit more than one comment on webform per item, only one comment will be read into the record for that item. Comments received after 4pm the day prior and before 8am the day of the meeting will be provided to the Commission or Committee and posted online with the meeting materials. All comments are limited to 200 words. Comments received after 8am the day of the meeting, but before the item is called, will be submitted into the written record for the relevant item. If you attach any documents to your comment, it will be distributed to the Commission or Committee in accordance with the deadlines described above.
