PRESENTATION AND DISCUSSION

Update on Hunger/Food Sustainability in San Diego

James Wright, Feeding America San Diego

- Received the 2014 Annual Hunger Study that is done every 4 years.
- Feeding America has 150 partners
- 64% of Families using our program are employed
- 27% are Active Military or Veterans
- 18% of people relying on Feed America are under 18 years of age and 9 % are over the age of 60.
- 69% of food we provide are grocery items and 31 % are hot meals
- 57% of our partners are Faith Based and 44% are Volunteers

Daniela Solano, San Diego Food Bank

- 28% of qualified people receive benefits
- 78% of people that qualify for the CalFresh Program are not receiving the benefit due to the following:
 - Application is overwhelming
 - o The clients are uninformed
 - o They think that they have to have children to qualify
 - o They think their immigration status will be compromised

- o "Selfie Moment" Spoontember posted and tweeted by HRC
- When you take a "Selfie Moment" with the orange spoon on your nose and post it on social media with the #Spoontember an anonymous donor will donate food to feed 8 people for the month of September.
