ACTION AGENDA – New Business

- Debrief March Commission meeting consider any further actions
 - Panel placement should be without backs to the audience
- 2015 Commission Priority Issues, Committees, and Action Items
 - Assembly Bill (AB) 66 by Assemblywoman Shirley Weber: This Bill would provide guidelines about when body worn cameras are to be operated, require notification of those being recorded, and prohibit law-enforcement officers involved in serious use-offorce incidents that result in serious bodily injury or death from viewing the video until they have filed an initial report.

- Deputy City Attorney offered that the HRC would be precluded from reviewing specific citizen complaints against San Diego Police officers, because that is not part of HRC's mission under the Municipal Code and is clearly the responsibility of the Citizen's Review Board for Police Practices (which Executive Director Danell Scarborough also administered until recently) under the San Diego City Charter.
- Request made that the item be continued in a committee forum.
- Committee Chairs and Action Plans
 - Commissioners identified the committees on which they would serve and chair
- Developing Standing Rules for Commission Business Meetings
 - Discussion regarding the ways to make the Commission meetings effective while respecting the requirements of the Brown Act.
- Gender-neutral restrooms in the City of San Diego (handout)
 - At the February 18th meeting the Commission was asked to research and take action or make a recommendation to the Mayor and City Council on the issue.
 - Discussed HRC Intern's research on the background of the issue

Motion made by Commissioner Dion Brown: to have the Commission draft a letter to the Mayor and City Council and present it at the May agenda for discussion and voting on a recommendation. 2nd by Commissioner Monica Bauer

Commissioner Shana Hazan offered an amendment to: have the motion include training around the issue. Amendment accepted by Commissioner Dion Brown

Chair's Report

City Attorney's guidance on supporting HAN Minimum Wage Statement

Deputy City Attorney addressed Chair Joel Trambley's concerns about whether HRC's support for the Hunger Action Network's (HAN) minimum wage statement would constitute taking a position on the City's referenda minimum wage ordinance, which is set for a vote in June 2016. The Deputy City Attorney's response was as follows:

- HAN's statement does not appear to endorse any particular proposal, because it states: "As specific minimum wage proposals are developed, [HAN] urges policymakers to evaluate whether these minimum wage increases are of maximum benefit to members of our community living in poverty and stand behind policies that supports our society as a whole."
- Based on the Deputy City Attorney's research the Commission (HRC) could take a position on a ballot measure in a properly noticed open and public meeting where all perspectives may be heard.
