#### **New Business**

1. Briefing on the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) and the County Commission on the Status of Women.

Motion from Commissioner Jessica Nare to explore supporting CEDAW in San Diego, California by joining them via their formal process. There are requirements and they are as follows: Support of 4 cities, the commitment of 60 thousand dollars yearly, a gender analysis, funding, and an oversight body.

Vice Chair, Susan Thomson-Tschirn: Why has the United States not ratified the United Nations Convention of 1977?

Commissioner Mark Dillon: Are there other agencies that already collect the same information? Vice Chair, Susan Thomson-Tschirn: Are there any opposing views?

Commissioner Godwin Higa: Is the National Organization of Women involved?

Commissioner Karyn Johnson: Can the City of San Diego do a gender analysis?

A request was made by Commissioner Jessica Nare to invite CEDAW to give a presentation to HRC.

2. Consider support for name change for local school - Robert E. Lee Elementary School

Motion from Commissioner: Godwin Higa to support the changing of the name due to its reference to confederacy, which has had controversy since the shootings by a white male in a predominately African/American Church in Charleston, South Carolina. Seconded by Commissioner Jessica Nare Information provided regarding the process of naming a school.

<u>Vote:</u> Aye <u>7</u> Nay <u>0</u> Abstention <u>1 (Vice Chair)</u> <u>Motion: Passes</u>

3. Consider support for Federal legislation – Voting Rights Advancement Act of 2015

Motion from Commissioner Monica Bauer that a letter be sent to the Congressional Delegation in support of restoring the Voting Rights Advancement Act of 2015. Seconded by Commissioner Dolores Canizales

<u>Vote:</u> Aye <u>9</u> Nay <u>0</u> Abstention <u>0</u> <u>Motion: Passes</u>

4. Review and approve proposed Standing Rule on Developing HRC Statements (Materials provided)

There was discussion that included the following suggestions/recommendations:

- b. That guidelines be produced to develop statements regarding current issues and relevance to the Commissions work and the effects on the Community we serve.
- c. That the Community be given the opportunity to respond and comment.
- d. That the Mayor's Office not be forgotten prior to a press release. (No Surprises)
- e. That as much back up information be provided regarding the topic.
- f. Local issue or National issue.
- g. Purpose of the Statement.
- h. Have we already made a Statement regarding this topic?
- i. Time constraints, still an unfolding topic.
- j. The Deputy City Attorney advised all to adhere to the Brown Act regulations and the Municipal Code (quorum)
