## In the Community

**Delegation from Latin America** 

The San Diego Diplomacy Council hosted a delegation of leaders representing government and civil society from Latin America as part of the U.S. State Department's International Visitor Leadership Program. The delegation was exploring the topic of migration in the Americas and included individuals from Colombia, Costa Rica, Ecuador, Guatemala, Honduras, Mexico, Paraguay, and Venezuela. OIA Executive Director, Rita Fernandez, joined the group on July 27 to share information about the Welcoming San Diego initiative, the creation of OIA, and Mayor Gloria's advocacy on immigration policy.

New International Rescue Committee (IRC) Anti-Corruption Case Management Program: The IRC in San Diego is launching a new Case Management program for survivors of Human Trafficking - sex and/or labor for adults regardless of immigration status. The IRC formally extends their services to any potential leads/referrals who will benefit from their services. The goal of the IRC is to have survivors of human-trafficking become self-sufficient and to continue to be an integral part of their communities.

Included in the 16 page guide is a list of resources and shelters located throughout Tijuana to support vulnerable immigrant populations.



## **Policy Updates and Other News**

#### **Federal**

DHS Announcement for Extension of Temporary Protected Status (TPS) for Venezuela: Secretary of Homeland Security, Alejandro Mayorkas announced the extension of TPS for Venezuela for 18 months. The 18-month extension will be effective from September 10, 2022 through March 10, 2024. Only beneficiaries under Venezuela's existing designation, and who were already residing in the United States as of March 8, 2021, are eligible to re-register for TPS under this extension. Venezuelans who arrived in the United States after March 8, 2021 are not eligible for TPS. Approximately 343,000 individuals are estimated to be eligible for TPS under the existing designation of Venezuela.

**DHS Announcement for Extension of Temporary Protected Status (TPS) for Syria**: Secretary Alejandro Mayorkas, announced the extension and redesignation of Syria for Temporary Protected Status (TPS) for 18 months, through March 31, 2024, due to the ongoing armed conflict and unstable conditions in the region. The extension of TPS for Syria allows approximately 6,448 current beneficiaries to retain TPS through March 31, 2024, if they meet TPS eligibility requirements. It is estimated that approximately 960 additional individuals may be eligible for TPS under the redesignation of Syria.

**DHS Announced a final rule to preserve and fortify DACA:** Secretary Alejandro Mayorkas announced that DHS issued a final rule that will preserve the

Deferred Action for Childhood Arrivals (DACA) policy for certain eligible non-citizens. Secretary Mayorkas expressed his support for such an "extraordinary program" that has assisted and transformed the lives of many, and asked Congress to pass legislation that would create a path to citizenship for Dreamers. This final rule will maintain the existing threshold criteria for DACA, retain the existing process for DACA requesters to seek work permits, and affirms the longstanding policy that DACA is not a form of lawful status but that DACA recipients, like other deferred action recipients, are considered "lawfully present" for certain purposes. This final rule will be effective October 31, 2022, however, due to an existing injunction, DHS is prohibited from granting initial requests for DACA under this rule.

#### State

**Expansion of Medi-Cal for low-income immigrant communities regardless of immigration status:** The California state budget for 2022-23 included important measures to address the needs of low-income immigrant communities throughout the state. This included the expansion of the Medi-Cal program and California Food Assistance Program to low-income communities regardless of immigration status.

Starting on May 1, Medi-Cal <u>extended its eligibility</u> for coverage to individuals who are 50 years of age or older, regardless of immigration status. The state budget this year also includes funding to expand Medi-Cal access to income-eligible undocumented Californians ages 26-49 starting in January 2024. With this expansion, California became the first U.S. state to guarantee healthcare for all low-income immigrants, regardless of immigration status.

On August 22nd, the state Department of Health Care Services announced it would continue to provide coverage to about 40,000 young adults through the end of 2023 to make sure they won't lose their benefits until the new law takes effect in 2024.

**Expansion of California Food Assistance Program to low-income immigrant communities regardless of immigration status:** The state budget also includes the expansion of the California Food Assistance Program (CFAP) to adults over the age of 55, regardless of immigration status which means that California will be the first state in the U.S. to provide state-funded food assistance to undocumented adults. Food assistance programs like CalFresh and CFAP reduce food insecurity, improve health, and provide vital support to California families.
