# The Month in Review

### **Cities for Action Call with JFFSD**

On January 4, 2023, Cities for Action hosted Jewish Family Service (JFS) of San Diego on a call to discuss best practices for emergency shelter and medical intake for asylum seekers. Kate Clark, Senior Director of Immigration Services at JFS and Linda Hill, Director of the UCSD/SDSU General Preventive Medicine Residency, which partners with JFS, spoke about their process for integrating newly arrived asylum seekers into their shelters and the medical intake process they use to screen people for Covid-19 and other health and mental health concerns. Over 70 participants from cities across the country joined the call.





# State of the City Now Available in Multiple Languages

San Diego Mayor Todd Gloria delivered his third State of the City (SOTC) address on January 11, 2023. Mayor Gloria detailed the considerable progress on the City's top issues and made several announcements, including an executive order that will expedite City approval of affordable housing projects to 30 days. This year's SOTC is now available online, and has been translated into Arabic, Chinese, Filipino, Spanish and Vietnamese.

# Sponsoring Refugees. Strengthening Communities.

On January 24, the White House held a webinar to discuss the new "Welcome Corps" program the Biden administration is implementing as part of its refugee resettlement efforts. The program was designed to create a public/private flagship initiative to connect private sponsors with newly arrived refugees. The sponsors will welcome the refugees into their communities, help connect them with healthcare and educational services, employment opportunities, and housing support. The goal of the program is to get 10,000 Americans to sign up as sponsors and aid 5,000 refugees in order to help meet the Biden administration's goal of welcoming 125,000 refugees into the United States in Fiscal Year (FY) 2023.

# **Policy Updates & Other News**

**Department of Homeland Security (DHS) announced the expansion of Title 42 and Process for Nicaraguans, Haitians, and Cubans Applying for Entry**: On January 5th, DHS outlined plans to expand Title 42 to expel asylum seekers from Nicaragua, Cuba, and Haiti and increase the use of expedited removals for nationalities that cannot be processed under Title 42. The department also announced that the CBP One app will be used as the mechanism for asylum seekers to schedule their appointment(s) at a U.S. port of entry. DHS plans to grant temporary parole, including work authorization, for up to 30,000 nationals from Haiti, Cuba, Nicaragua, and Venezuela who apply online through the app and are eligible based on a background check, health requirements, and U.S. sponsor documentation.

**United States Citizenship and Immigration Services (USCIS) Proposed Fee Rule Changes**: USCIS has issued a notice of its proposed fee schedule, which includes both increases and decreases in certain fees for immigration applications. New measures include a proposal to incorporate biometrics costs into the main application fee, establish separate fees for some nonimmigrant

classifications, and institute lower fees for certain forms filed online, among others. However, the proposed rule would not change fee waiver eligibility requirements. Under the proposed fee schedule, USCIS would expect to receive an average of \$5.2 billion per year during FY 2022 and 2023, which would generate an additional \$1.9 billion per year on average. There is a 60-day public comment period which ends March 6, 2023. Fees will not change until and if the final rule goes into effect, after the public comment period and after USCIS reads and responds to each comment.

Secretary Mayorkas Extends and Redesignates Somalia for Temporary Protected Status for 18 Months: On January 12th, DHS announced the extension of TPS for Somalis for 18 months, from March 18, 2023, through September 17, 2024. The humanitarian crisis in Somalia is ongoing and rife with violent conflict and natural disasters, making it continually unsafe for Somalis to return. The redesignation of TPS will allow additional Somali nationals to receive benefits under TPS, which DHS estimates will apply to 2,200 Somalis. A Federal Register notice will soon be published with details on the timeline, procedures, and eligibility criteria for new applicants and those renewing their status under TPS.

**DHS Announces Process Enhancements for Supporting Labor Enforcement Investigations :** On January 13th, DHS outlined a new process for immigrant workers to request temporary protection from removal through deferred action or parole in place. This process will take place if a federal, state, or local agency is investigating labor exploitation that the immigrant worker is subject to or has witnessed. The labor agency must submit a letter to DHS on behalf of the worker supporting the request, which can also include a request for employment authorization for the noncitizen if they demonstrate "an economic necessity for employment."

**Asylum Applicants Can Now File Form I-765 Online:** USCIS announced that certain asylum applicants can now file Form I-765, Application for Employment Authorization (EAD), online. To file an EAD online, you must first visit **my.uscis.gov** to create a free USCIS online account. Online filing for Form I-765 is only available to certain categories of applicants. If you submit Form I-765 online and you are not filing under an eligible category, USCIS may deny your application without refunding the fee. **USCIS Extends Green Card Validity for Conditional Permanent Residents with a Pending Form I-751 or Form I-829:** USCIS is extending the validity of Permanent Resident Cards (Green Cards) for petitioners who properly file Form I-751, Petition to Remove Conditions on Residence, or Form I-829, Petition by Investor to Remove Conditions on Permanent Resident Status, for 48 months beyond the card's expiration date. This change started on January 11, 2023, for Form I-829 and started on January 25, 2023, for Form I-751. The change is being made to accommodate current processing times for the two forms, which have increased over the past year. USCIS has also updated the language on Form I-751 and Form I-829 receipt notices to reflect the extended date validity. By presenting an updated receipt notice with an expired Green Card, an individual may remain authorized to work and travel for 48 months from the expiration date on the front of their expired Green Card.

**USCIS Extends COVID-19-related Flexibilities:** USCIS is extending certain COVID-19-related flexibilities through March 23, 2023. Under these flexibilities, USCIS will continue to consider a response received within 60 calendar days after the due date set forth in certain requests or notices before taking any action, if the request or notice was issued between March 1, 2020, and March 23, 2023. In addition, USCIS will continue to consider Form I-290B, Notice of Appeal or Motion, or Form N-336, Request for a Hearing on a Decision in Naturalization Proceedings, if the form was filed up to 90 calendar days from the issuance of a decision made made by USCIS, and the decision was made between Nov. 1, 2021, and March 23, 2023. Barring any other pandemic-related difficulties, USCIS anticipates that this will be the final extension of these accommodations. The original flexibility regarding due dates, which was announced in March

2020, became a permanent policy on July 25, 2022. You can visit **uscis.gov/coronavirus** for USCIS updates related to COVID-19.
