Welcoming Week 2022

OIA kicked off Welcoming Week 2022, September 9th-18th, by illuminating Balboa Park with the colors of the Welcoming Week 2022 campaign.

Welcoming Week is an international campaign organized by Welcoming America to showcase the importance of welcoming newcomers into our communities. This year Welcoming America recorded 450 events in 32 states and 7 countries, with 6 million people participating. OIA would like to thank everyone who participated in Welcoming Week activities and who continue to welcome immigrants into their communities.

#### **Climate Migration Council Announcement**

Rising temperatures and climate disasters are forcing a record number of people across the world to migrate. According to the World Bank, over 200 million people will be displaced by 2050 as a result of climate change. As America's largest border city, San Diego is at the front lines of welcoming immigrants, including many impacted by the effects of climate change.

On Monday, September 19th, the <u>Climate Migration Council</u> was created to address this isssue and we are proud to share that San Diego Mayor Todd Gloria is one of the group's founding members. Mayor Gloria will be joining this new coalition of global leaders that includes José Andrés, Manish Bapna, Mark Hetfield, Roberta Jacobson, Claudia López Hernández, David Miliband, Cecilia Muñoz, Janet Napolitano, Leon E. Panetta, Laurene Powell Jobs, and Vittoria Zanuso. The Council will focus on building a commitment to put people at the center of climate action and accelerate global solutions to climate-driven migration.

The group recognizes that the climate crisis acts as a powerful driver of migration patterns, and that there remains a global need for legal pathways, clear institutional leadership, and new integrated strategies at all levels of government to anticipate and safely accommodate the increasing numbers of people affected by this crisis.



**Cities for Action Letter to Biden Administration on Refugee Admissions** The <u>Cities for Action Coalition</u> sent a letter to President Biden to reaffirm US commitment to the refugee admission goal for fiscal year (FY) 2023: 33 mayors across the US, including San Diego Mayor Todd Gloria, sent a letter to President Biden urging him to reaffirm the United States' commitment to resettle refugees by maintaining the FY 22 refugee admission goal of 125,000 for FY 23. This includes making use of all the necessary humanitarian programs to assist individuals in need of protection from disasters, conflicts, oppression, and persecution. The coalition noted that world is currently facing its greatest refugee crisis, with over 100 million people displaced globally. On September 8th, the US State Department issued its report to Congress on proposed refugee admissions for FY 23 and kept the goal at 125,000 people.

#### Dear President Biden,

As leaders representing local governments around the country, we urge you to reaffirm the United States (U.S.)' longstanding commitment to refugees by at the very least:

- Maintaining the refugee admission goal for FY 2023;
- Taking all necessary steps and providing needed resources to meet this goal; and
- Strengthening other humanitarian programs to assist individuals in need of protection from disasters, conflicts, oppression, and emergencies.

As cities and counties from across the country, we are at the forefront of welcoming refugees and integrating immigrants into our communities. We know firsthand that we all benefit from the tenacity, courage, diversity, and skills that refugees bring. Welcoming them increases creativity, innovation, and economic growth in our communities.

We applaud your decision to raise the refugee cap to 125,000 for FY 2022. According to the United Nations High Commissioner for Refugees (UNHCR)<sup>1</sup>, currently over 100 million people have been displaced worldwide, more than any time in recorded history, with two million of them needing urgent access to resettlement this year. Given these dire circumstances, we ask that the refugee admission goal for FY 2023 be maintained at least at this current level.

## **Policy Updates and Other News**

#### Federal

**USCIS Extends Permanent Resident Card Validity Extension to 24 Months for Renewals:** On September 28th, USCIS announced that as of September 26th, Permanent Resident Cards (Green Cards) will be automatically extended from 12 months to 24 months for lawful permanent residents who properly file I-90 forms. This allows for the I-90 form receipt to serve as evidence of approved continued status. For more information, visit <u>this link</u>.

U.S. ends one immigration pathway for Afghan evacuees, shifting to long-term strategy: This change in policy will shift the title of the government's mission from Operation Allies Welcome to Operation Enduring Welcome. This move from the US is a sign of a new phase in evacuation efforts as the nation marks one year since the military withdrawal from Afghanistan. The change will also ensure that those who arrive from Afghanistan come with a more stable immigration status; however, those who are given humanitarian parole at ports of entry will now be given only two years to secure another immigration pathway.

#### Industries across the US are putting pressure on the Senate to pass the Farm

<u>Workforce Modernization Act</u>: This bill would create a path to citizenship for foreign workers, grant legal status to undocumented laborers, and allow seasonal workers to legally remain in the country for longer. This legislation would also assist with the US labor shortage, especially within the agricultural sector. If the US does not address this issue by providing work visas and passing the Farm Workforce Modernization Act, the labor shortage could double over the next decade.

#### Department of Homeland Security (DHS) released final version of the Public Charge

**Rule**: DHS released a final version of the public charge rule of inadmissibility. The new version restores the historical understanding of 'public charge' that had been in place for decades, until the Trump administration changed the reading of the rule. Specifically, the prior administration wanted to consider supplemental public health benefits, such as Medicaid and nutritional assistance, as part of the public charge inadmissibility determination. Upon releasing the new version of the rule, DHS Secretary Mayorkas stated that "This action ensures fair and humane treatment of legal immigrants and their US citizen family members." DHS once again will not consider receipt of certain non-cash benefits for which noncitizens may be eligible, such as:

- Supplemental Nutrition Assistance Program or other nutrition programs
- Children's Health Insurance Program
- Medicaid
- Housing benefits
- Any benefits related to immunizations or testing for communicable diseases

The final rule will be effective on December 23, 2022, and was published in the Federal Register on September 9, 2022.

**Updates on** <u>Bridging the Gap for New Americans Act</u>: This bill was passed in the House on September 19, 2022, after being introduced in the Senate in 2021. The bill would require the Department of Labor to submit to Congress a study on the factors affecting employment opportunities for individuals with professional credentials obtained in a non-U.S. country, specifically individuals who are lawfully present noncitizens or naturalized U.S. citizens. The study described in the bill will not record data or take into account undocumented individuals or those working who are unlawfully present/not naturalized in the U.S. Additionally, the bill dictates that Congress shall work with relevant non profit organizations and State agencies to use the existing data and resources of such entities to conduct the study. President Biden has not yet signed the bill into law.

#### State

**California Governor Newsom passes SB 836 presented by California Senator Scott Wiener:** California Senator Scott Wiener introduced this legislation extending the safeguards in SB 785, which protected a person's immigration status in a public court record unless the presiding judge determined that immigration status was relevant to the proceeding. The previous legislation had a sunset date of January 2022, but in SB 836 no new sunset date was added, making this protection permanent.

**California IDs for All:** On September 23rd, Governor Newsom announced the signing of the California IDs for All bill, which will support immigrants, expand opportunity, and advance equity in the state.

Specifically, undocumented Californians will be eligible to obtain a state ID, which is critical for many public benefits at the state and local levels. For example, street vendors will be able to more easily obtain local health permits, immigrant students will have improved access to in-state tuition at public colleges and universities, and low income immigrants will be eligible for legal assistance in civil matters. This legislation presented by the California State Legislature and signed by Governor Newsom demonstrates that California is a welcoming state for all.
