City of San Diego Weekly Immigrant Affairs Update

On January 25, the Biden administration convened its first meeting of the <u>President's Interagency Task Force to Monitor and Combat Trafficking in Persons</u> (<u>PITF</u>). The PITF has primary responsibility for coordinating efforts across 20 Federal agencies to combat trafficking in persons, and implementing the recently released <u>National Action Plan to Combat Human Trafficking</u>.

U.S. Citizenship and Immigration Services (USCIS) has updated its <u>Policy Manual</u> to reflect new guidance on how they evaluate requests for <u>expedited treatment</u>.

CITY PROGRAMS, SERVICES, & UPDATES

- This week <u>the City of San Diego unveiled</u> the new <u>Strategic Plan</u> (in Spanish <u>here</u>) and <u>interactive dashboard</u>, outlining how the City plans to positively affect the lives of residents. Its priority areas include a focus on housing, mobility and infrastructure, community, sustainability and regional prosperity.
- As part of <u>Cities For Action</u>, the City of San Diego urged the federal government to prioritize language access in its effort to distribute COVID-19 test kits. Read the statement <u>here</u>.
