
Both the Lampshade House and Dr. Figueredo Buildings are visually prominent historical buildings part of the popular scenic Whale View Point coastline, and in the historical context of the proposed NR district. The inland boundary could be moved inland to Coast Blvd., South in the same way it is located inland to include Casa de Manana withing the district boundaries.




Suggested modifications to district boundary lines (Excerpt from Nomination Sketch Map 1 of 2: North, sheet 9-67)
