4. Letter to the Chief of Police recommending line up training for all SDPD Patrol Officers on the signs of youth and adults being trafficked.
5. Letter to Mayor and Chief of Police requesting a report on the suppression activities related to gangs and human trafficking to specifically address targeted sweeps and any biased focuses that might occur.
