Re-designate a 3-lot parcel (APNs 627-302-43, 627-302-44, 627-302-45) from Low-Density Residential to High-Density Residential and rezone from RS-1-7-1 to RM-3-9 Zone with a request to create a Community Plan Implementation Overlay Zone Type A (CPIOZ-A), to limit the uses on the site, to residential. The 0.80-acre site is located at 920 Saturn Blvd. There is no proposed development associated with this project. The Palm & Hollister project is located on a 5.92-acre site in the Otay Mesa-Nestor Community Plan area. The project proposes development of 198 multi- family housing units, including eight affordable units, proximate to the Palm Avenue Trolley Station. The proposed project requires an amendment to the Otay Mesa-Nestor Community Plan to change the existing land use designation from Open Space to Residential Medium-High Density (20-35 du/nra), a Rezone to change the existing zone from AR-1-2, RM-1-1, and RS-1-5 to RM-2-6, a Tentative Map, Site Development Permit and Neighborhood Development Permit, and an MHPA Boundary Line Adjustment.
