More District Five Streets Getting Repairs

You may have heard, or even seen for yourself, that a portion of Paseo Montalban in Rancho Peñasquitos was recently repaired using a new “mill and pave” method funded in the City’s 2015 budget. I am happy to report that it won’t be the only street to receive repairs in the last quarter of 2014. The remaining portions of Paseo Montalban will also be repaved. Those stretches include the portions from Via Cima Bella west to Black Mountain Road and from Carmel Mountain Road east to Paseo Cardiel. Also on the list for repaving are:

- Greens East Road from Bernardo Oaks Drive to Pomerado Road
- Hillero Court in Rancho Bernardo
- Black Mountain Road between Oviedo and Calle de Vista Oeste
- Black Mountain Road between Miramar Road and Carroll Centre Road
- Oviedo Street between Barrymore Street and Black Mountain Road

Additionally, a stretch of Pomerado Road between Espola Road and I-15 is also being repaired using the new mill and pave method. As you know, rebuilding San Diego is my top priority. As your City Councilman, I will continue to find new ways of repairing our streets, sidewalks and City facilities.

New Four Way Stop in Sabre Springs

Neighborhood safety is important to me. A few months ago it came to my attention that the intersection at Springbrook Dr. and Mil Pitrero Rd., in the community of Sabre Springs, posed a danger for our residents walking the area.

I am delighted to share that on October 22nd, a four-way stop and new signage were installed at the intersection. Previously, only a two-way stop existed. At a Sabre Springs/Carmel Mountain Ranch Community group meeting in August, several incidents were shared by surrounding residents.

Thanks to the leadership and involvement of residents in the community, like Keith Landt, as well as the hard work of our Traffic and Engineering Department, this new four-way stop will increase neighborhood safety for surrounding residents.

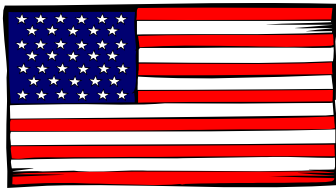
Scripps Ranch Community Center Renamed



In what is a well deserved honor for the Scripps Ranch Civic Association (SRCA), the community center located at 11885 Cypress Canyon Rd. is now officially named the **SRCA Community Center**. The SRCA is one of the most engaged community groups in the City and its center has become somewhat of a hub for the Fifth District. The City's Parks and Recreation Board made the new name official at a meeting in October.

SRCA negotiated with McMillin when they were selling homes in Miramar Ranch North to have the sales office building donated to the community and moved to the current site. In 2009, when the Center faced closure due to City budget cuts, it was the SRCA that stepped in to be sure it remained available to the public. Over the years, the Center has brought countless services to the community and provided dozens of community organizations with meeting space. Without the SRCA there would be no community center, so it's only right that the it bear the organization's name.

The new hours demonstrate the commitment we have to our kids and their access to learning spaces in the community. They also provide time for a new afterschool homework program at the library in Scripps Ranch which will launch late fall. The new hours at branch libraries are as follows:

Monday 9:30 a.m. – 6:00 p.m.	Thursday 9:30 a.m. – 6:00 p.m.
Tuesday 11:30 a.m. – 8:00 p.m.	Friday 9:30 a.m. – 6:00 p.m.
Wednesday 11:30 a.m. – 8:00 p.m.	Saturday 9:30 a.m. – 3:00 p.m. (23 branches)

The library in Rancho Bernardo is one of 12 citywide that will have additional hours on the weekend. Those hours are: Saturday 9:30 a.m. – 6 p.m. and Sunday 12:30 p.m. – 5:00 p.m.



Water Rebates Available to San Diego Residents

San Diegans have already done a fantastic job saving water over the past several years. For many residents, finding new ways to save water during the drought can be challenging. I want to make sure you are aware of the

following rebate programs available to all City of San Diego water customers through the City, San Diego County Water Authority (SDCWA) and the Metropolitan Water District's SoCal Water \$mart program.

- **Rain Barrel:** Rebates for barrels that catch and store rain water. Receive up to \$1.00 per gallon of barrel storage capacity for residential rainwater harvesting (rain barrel) rebate program, up to 400 gallons and \$400 per property. For City residential customers only.
- **Mulch from Miramar Greenery:** City of San Diego residents may load up to 2-cubic yards of mulch for free with proof of residency. Applying mulch around the plants in your flower beds and garden will reduce the need to water as often. For residential and commercial customers.
- **Turf Replacement Program:** Replace turf grass with water-efficient landscaping options more suited to the county's semi-arid climate at \$1.50 per square foot via SDCWA.
- **Soil Moisture Sensor Systems:** Rebates start at \$80 or \$35 per irrigation controller station for large residential sites via SoCal Water \$mart.

For additional help finding ways to save water, I encourage you to schedule a free residential or business water survey. As part of this program, a Water Conservation Representative will tour your property to identify leaks and water-saving opportunities. Mandatory Water-Saving Measures Implemented

Due to extremely dry conditions expected this winter, the City Council has declared a Drought Level Two Emergency triggering mandatory water-saving measures that went into effect on November 1. Most refer to the use of water for landscaping. Here are a few key measures to remember:

- **Assigned watering days:**
 - Residences with odd-numbered addresses Water only on Sunday, Tuesday & Thursday
 - Residences with even-numbered addresses Water only on Saturday, Monday & Wednesday
 - Apartments, condos & businesses Water only on Monday, Wednesday & Friday
- **Time of day and time limits:**
 - From November 1 through May 31, water only between 4 p.m. and 10 a.m. for only 7 minutes at each station when using a standard sprinkler system.
 - From June 1 through October 31, water only between 6 p.m. and 10 a.m. for only 10 minutes at each station when using a standard sprinkler system.
- **Potted plants, non-commercial vegetable gardens and fruit trees may be irrigated on any day during the following times:**
 - Between 4 p.m. and 10 a.m. from November 1 through May 31
 - Between 6 p.m. and 10 a.m. from June 1 through October 31.

He is the founder and owner of Kersey Strategies, a technological research firm specializing in the telecommunications and high-tech industries. Mark is a long-time supporter of the Rady Children's Hospital Foundation, and served for five years as the Advisory Board Chair of First Book San Diego, a non-profit organization dedicated to improving childhood literacy.

In addition to chairing the Committee on Infrastructure, Mark is Vice Chair of the Economic Development & Intergovernmental Relations Committee. He is also a member of the Public Safety & Livable Neighborhoods Committee and the Budget & Government Efficiency Committee.

Development Permit Info Now Online

One of my constant struggles with how we do city business has been the lack of online information and services available to our residents. So I am very pleased to share development permit and contract information is now available online. That means residents who are undergoing a remodel of their home can track the progress of their permit application using the City's new OpenDSD website.

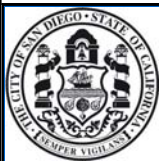
Using Google Maps, [the OpenDSD website](#) uses a software system to manage and track the City's land development permit processing functions. Now, property owners and designers can get up-to-the-minute status updates on events transpiring in their project; monitor inspection activity; confirm development process timelines; and validate permits when selling property.

The Project Tracking System (PTS) uses a web-based format to indicate DSD permit and code enforcement data, permit application information, project descriptions, project status, inspection outcomes, permit types needed, sign-offs from staff, expected fee amounts and staff contact information.

But it doesn't stop there. In December, local businesses seeking San Diego permits will also be able use OpenDSD to pay and schedule inspections online.
