REQUEST FOR PROPOSALS Development and Operation of Concession Facilities at various City-Owned Reservoirs

The following changes to the specifications are hereby made effective as they were originally issued with the Request for Proposal. Proposers are reminded that all previous requirements to this solicitation remain in full force and effect.

- 1. The Proposal deadline date has been extended to 4:00 p.m., Thursday, January 5, 2017.
- 2. Delete Addendum A Request for Proposal cover sheet and <u>replace</u> with the attached Request for Proposal cover sheet. (Note: Addendum B has been noted and Proposal Deadline date has been changed).

The following questions were asked regarding this Request for Proposals (RFP):

1. **Question:** Would it be possible to extend the duration of the RFP?

Response: Yes, the RFP response deadline will be extended. The revised Proposal Deadline Date will be 4:00 p.m., on January 5, 2017.

2. Question: What were the visitor numbers and revenues for each individual reservoir listed in the RFP during 2015?

Response:

El Capitan – Fishing permits = 33,856 Water Contact (Personal watercraft, wake boarding, waterskiing, tubing, kneeboarding) permits = 9,367

Hodges – Fishing permits = 9,960

Miramar – Fishing permits = 3,842

Murray – Fishing permits = 13,725

Otay – Fishing permits = 14,331 San Vicente – Closed Sutherland – Fishing permits = 2,690

3. Question: What was the total revenue in 2015 for all reservoirs listed under the RFP?

Response: The total permit revenue in Fiscal Year (FY) 2015(i.e. July 1, 2014 through June 30, 2015) for all reservoirs listed in the RFP was \$837,417

4. **Question:** What are the historical revenues from 2010–2015 for all reservoirs listed under the RFP?

Response: The following are the total permit revenues for all the reservoirs by Fiscal Year:

Response: The City does not have this information.

6. Question: What are the monthly gross receipts of non-motorized boat rentals for each month of operation in 2016?

Response: The City does not have this information.

7. Question: What are the monthly number of customer receipts of non-motorized boat rentals for each month of operation in 2016?

Response: The City does not have this information.

8. Question: Would the City allow the concessionaire to open, at a minimum, Wednesday – Sunday at all sites under the RFP?

Response: No, the following list reflects the specific days that City will allow the concessionaire to operate. The concessionaire must propose the hours of operation for each day of allowed operation. The schedule of days of operation for each of the concessions is as follows:

El Capitan – Friday thru Tuesday (year around)

Hodges – Wednesday, Saturday, Sunday (February thru October) Miramar – 7 days a week (year around) Murray – 7 days a week (year around) Otay – Wednesday, Saturday, Sunday (year around) San Vicente – Thursday thru Monday (year around) Sutherland – Friday, Saturday, Sunday (March thru September)

9. Question: What sites under the RFP would the City allow the concessionaire to operate for a minimum of 5 days a week?

Response: The following list reflects the specific days that City will allow the concessionaire to operate. The concessionaire must propose the hours of operation for each day of allowed operation. The schedule of days of operation for each of the concessions is as follows:

El Capitan – Friday thru Tuesday (year around)

Hodges – Wednesday, Saturday, Sunday (February thru October)

Miramar – 7 days a week (year around)

Murray – 7 days a week (year around)

Otay - Wednesday, Saturday, Sunday (year around)

San Vicente – Thursday thru Monday (year around)

Sutherland – Friday, Saturday, Sunday (March thru September)

11. Question: How many boating tickets were reported stolen at each individual reservoir in 2015?

Response: The City does not have any reports of stolen boating tickets.

12. Question: How many motorized boats does the current concessionaire have onsite in 2016?

Response: The following is an estimate, as the boats are rotated throughout the reservoirs based on the needs of each reservoir.

El Capitan – 5 Hodges – 20 Miramar – 9 Murray – 17 Otay - 15 San Vicente – 35 Sutherland – N/A

13. Question: How many non-motorized boats does the current concessionaire have onsite in 2016?

Response: The following is an estimate, as the boats are rotated throughout the reservoirs based on the needs of each reservoir.

El Capitan –0 Hodges – 12 Miramar – 10 Murray – 14 Otay – 28 San Vicente – 11 Sutherland – N/A

14. Question: What is the estimated cost for capital improvements to operate each reservoir listed under the RFP at a standard satisfactory to the City?

Response: The City does not have this information.

15. Question: Would the City be open to other non-motorized vehicles, aside from canoes and kayaks, on the reservoirs under the RFP?

Addendum "B" December 05, 2016 **Response:** Yes, so long as the proposed non-motorized vehicles comply with all applicable local, state and federal requirements, regulations and laws, including, but not limited to safety and the City's Storm Water Regional Control Board Permit, and they do not interfere with existing recreation programs.

16. Question: Which reservoir locations under the RFP would the City allow Standup Paddle Board rentals?

Response: The City will not allow standup paddle board rentals at this time on any Reservoir.

17. Question: Would the City allow the concessionaire to act as the liaison / intermediary on events, including bass fishing tournaments, at all reservoir locations included in the RFP?

Response: Concessionaire may be open and offer their services during these special events, such as tournaments.

18. Question: Can the City list all Reservoirs under the RFP that charge a parking fee and the price to park at each location?

Response: The City does not charge parking fees at any of the Reservoirs.

19. Question: Would the concessionaire be responsible for collecting parking fees?

Response: No, the City does not charge parking fees at any of the Reservoirs.

20.Question: Would parking fee revenue be split between the city and concessionaire?

Response: No, the City does not charge parking fees at any of the Reservoirs.

21. Question: In the RFP the City asks for the concessionaire to upgrade fixtures. What specific fixtures is the City looking to upgrade?

Response: The Proposer is not required to upgrade fixtures, but may do so based on business needs with prior written approval from the City.

22.Question: If there was a drought condition and the reservoirs were forced to be closed, would the City be open to forgoing rent on the months the concessionaire could not operate?

Response: Section C.3.f. <u>Closures</u> of the RFP, states, "[T]he City cannot guarantee that any individual Reservoir will be open for fishing or other activities at all times. If any such closure should become necessary, the City may, at the City's sole discretion, reduce the agreed-upon rent in proportion to the length of any closure."

23. Question: If there was a drought condition and the reservoirs were forced to be closed, would the City be open to extending the agreement for locations effected for the number of months/ days out of operation?

Response: No, the agreement will have a specified expiration date that will not be extended. **Section C.3.f.** <u>Closures</u> of the RFP, states, "[T]he City cannot guarantee that any individual Reservoir will be open for fishing or other activities at all times. If any such closure should become necessary, the City may, at the City's sole discretion, reduce the agreed-upon rent in proportion to the length of any closure."

24. Question: Does the City charge a fee for hand-launching?

Response: Yes, a fee for hand-launching is charged at Hodges, Miramar, Murray, Otay, and Sutherland.

25.Question: Would hand-launching fees be split between the city and concessionaire? If so, what is the revenue split?

Response: Pursuant to Section 6. <u>Records and Reports</u> of the RFP, in return for sale of the permits, the selected Proposer shall receive as commission, an amount equal to no more than five percent (5%) of the permit sales. Proposed percentage of the permit sales to calculate the commission shall be offered in proposals submitted to this RFP.

26.Question: How many full-time employees are at each location currently?

Response: The City does not have this information.

27. Question: How many seasonal employees are at each location currently?

Response: The City does not have this information.

28.Question: Please delineate all maintenance responsibilities that would fall under the concessionaire or the city?

Response: As stated in Section C.21 <u>Maintenance</u> of the RFP, concessionaire is responsible for all maintenance and repairs. Examples of concessionaire's maintenance and repair responsibility are interior paint, lighting, plumbing, electrical, doors, windows, and screens. The City will maintain the structural supports and exterior walls, roof and floor of the buildings of the Concessions Facilities in good order and repair.

29.Question: Is there any deferred maintenance at the sites listed in the RFP? If so, what are the estimated costs?

Response: The City does not have this information.

30. Question: Is there a termination clause in the agreement?

Response: A termination clause is not anticipated in the agreement. However, it may be negotiable.

31. Question: If there is a termination clause, is it mutual for both parties? What is the notification term?

Response: A termination clause is not anticipated in the agreement. However, it may be negotiable.

32. Question: If there is a termination for convenience or cause, is the concessionaire's amortized investment subject to a city or successor concessionaire buyback?

Response: A termination clause is not anticipated in the agreement. However, it may be negotiable. Amortization, buyback, etc., may be negotiable.

33. Question: Please provide 3 year attendance and financial information included in reports to the City by the current operations.
