The RFI Amendment updated the use of alternative daily covers (ADC); The following represent the changes to ADC: materials, cover frequency; types of materials, synthetic membrane cover (tarps), processed green waste, disposable polyethylene film, foam cover, beneficial reuse types, alternative intermediate cover options, final cover, and alternative final cover.
