5. LAND DEVELOPMENT CODE UPDATE: Action Item

Amanda Lee, Senior Planner, DSD, provided an overview of the 8th Update to the Land Development Code (LDC).

- 1). Motion by Jim Varnadore, City Heights motion to recommend no change to current Sidewalk Café regulations, shown as Issue #12 on the Draft Issue Matrix. . Seconded by Laura Reibau, Eastern. Motion failed by a vote of 6-17-1. 1 Abstention: La Jolla.
- 2). Motion by Beth Jaworski, Uptown, to retain the current clear path of travel requirements related to Issue #12 Sidewalk Café regulations. Seconded by Jim Baross, Normal Heights. Motion failed by a vote of 8-15-1. 8 Favor: North Park, City Heights, Kensington/Talmadge, Normal Heights, Uptown, Rancho Bernardo, Eastern and Ocean Beach. 1 Abstention: La Jolla.
- 3). Motion by Beth Jaworski, Uptown, to accept the staff recommendation to change the Sidewalk Café permit process from a Process 2 to a Process 1. Seconded by Drew Corley, Linda Vista. Motion passed by a vote of 14-9-1. 9 Against: Southeastern, City Heights, Encanto, Ocean Beach, Rancho Bernardo, College, Kensington/Talmadge, Eastern and North Bay. 1 Abstention: Uptown.
- 4). Motion by Beth Jaworski, Uptown, to accept the staff recommendation to remove the Sidewalk Café barrier requirement. Seconded by Jon Becker, Rancho Penasquitos. Motion passed by a vote of 16-7-1. 7 Against: North Park, Scripps Miramar Ranch, Skyline/Paradise Hills, Southeastern, City Heights, Ocean Beach and Normal Heights. 1 Abstention: La Jolla.

Motion passed by a vote of 15-7-1. 7 Against: North Park, Southeastern, City Heights, Ocean Beach, Eastern, Kensington/Talmadge, and Normal Heights. 1 Abstention: La Jolla.
