- Waterfront Activation Study / Water Access Feasibility Study from Cesar Chavez Park
- b. Powerpoint Purpose of Study is to assess feasibility of access for small craft launching
- c. Input has been taken by a variety of groups
- d. Currently Pacific Tugboat leases the area
- e. Option 1: Floating docking area, Option 2 Pathway from Park to the bay
- f. Challenges: Public Safety and other factors Comments:
- Build a floating dock off the existing pier for hand launched watercraft
- What will this lead to in terms of larger luxury craft wanting access next
- This item needs further review; there are many other suggestions for use.
- What will be the usefulness of this project to local residents since few if any own water craft
- An member of the community #1 provided a character reference for John Alvarado and stated that the project can offer an alternative activity for our youth
- the projects lack of relevance to the local community
- Opportunity for educational and science oriented uses for the are for our youth and students
- Environmental issues and rising water levels in the future from an engineering standpoint
- Individual not in favor of this project since it would not benefit the local community, especially since the water is severely polluted, hazardous cargo ship traffic. Suggested rather that attention should be given to improvements of Cesar Chavez Park
- g. Mark Steele summarized the discussion with a vision of the 25th Street terminus from Balboa Park.
 - Comment: Josie Talamantes stressed that the Historical Chicano Park be considered in in this vision and not just Balboa Park
