VI. Comments from Planning Group

- a. Brent Beltran reported the need for a traffic light or stop sign at the intersection of Freeway 5 southbound ramp and Logan Heights. Noting that it is a very dangerous intersection specially around 2-3 pm (NASCCO shift change)
- b. Jossie Talamantes reported that there is no wheelchair accessibility ramp at that same intersection and makes the crossing that much more dangerous.
- c. Mario Chacon, David Favela and Elvia Martinez reported that shipyard noise & light pollution is unbearable and would like to request SD Port to intercede on behalf of Barrio Logan residents. Ken Powell agreed to take these complaints to the Port Tenants to request modifications to minimize negative impacts.
- d. Mark Steele suggested that members of the Barrio Logan Planning group should take the lead and 'stay in touch' with both The Port Authorities and Councilman Alvarez's office and report to community on the responses to the issues reported at this meeting. Brent Beltran and Mario Chacon volunteered.

VII. New Business

a. Stephan Barts from SANDAG reported on Bay Shore Bikeway Project. The proposed bike path will traverse Barrio Logan at Harbor Drive and some sections of street parking and NASSCO parking will be relocated to accommodate bike path. Community is invited to participate in Stakeholders' meetings in April and May to provide comments and feedback to SANDAG. The project will require funding from local and state agencies and SANDAD has allocated most of the funding while gap funding is being requested to the state.
