# 4. ADOPTION OF THE AGENDA:

A. Patrick Ambrosio made motion to approve the agenda as presented; the motion on the agenda was 2nd by Steve Ward; vote unanimously (8-0-0) by the ENCPG to adopt agenda was passed.

#### 5. APPROVAL OF MINUTES:

A. Patrick Ambrosio made motion to approve the minutes as presented; the motion on the agenda was 2nd by Steve Ward; vote unanimously (8-0-0) by the ENCPG to approve minutes of last meeting was passed.

## 6. CHAIR'S REPORT:

- A. Ken M. provided an update that affordable housing specialists will be coming to the ENCPG to provide insight to affordable housing topics.
- B. Weds. March the 19<sup>th</sup> at Jacobs Center; the San Diego Foundation is conducting a search for a new CEO and wants community input, all are encouraged

## 7. STAFF REPORTS:

- A. City Council Reports Councilmember Cole will be having a satellite neighborhood office at the Cesar Chavez Building on Euclid Avenue with District hours of operation on every Friday from 10AM-2PM. Officer Christopher Wilson was killed in the line of Duty, at the vigil which was held at a park; community request now in asking to give a new name to the park in the Memorial of Officer Wilson. The San Diego City Park & Rec. Board has already approved the concept for the park's name to be changed.
- B. Mayor's Office Report In the future ENCPG meetings will receive reports from Representative, Darnisha Hunter
- C. City Planning Staff Karen Bucey then gave an update that she would like the ENCPG subcommittee to meet to discuss matters on Land use. A member of the ENCP posed a question: "Where are all of the cell-towers located and did the City have a map or database to reflect all of the locations in the ENCP area?"

Ms. Bucey replied, "No, that a master map did not exists. Furthermore, the City has no such database to show where all of the towers are located."

### 8. INFORMATION ITEMS:

A. Fast Response Squad (FRS) Pilot Program for the community of Encanto Presenter: Fire Dept. Deputy Colin Stowell, San Diego Fire-Rescue: Hand-outs were given with questions that were answered by public & the ENCPG. The two (2) persons 12 hour crew is still searching for a permanent office location. The Fire Captain and the Firefighter/Paramedic are a part time proposal as the Skyline Fire Station is still under construction, and the Station is not yet fully funded.  B. Metropolitan Transit System (MTS) Traction Power Substations Installation at Imperial Ave & Woodman St. overview:
 Presenter: Sharon Cooney - hand-outs were given with questions that were answered by public & the ENCP. Even though the San Diego Trolley Renewal project was not required to come before the ENCP, MTS took feed-back back to their Consultants for review.

## 9. ACTION ITEMS:

- A. South Chollas Canyon Access, Project # 355106 Presenter: Thinh Tran, Principal Engineering Aide, City of San Diego: Hand-outs were given with questions that were answered by public & the ENCP. The majority (80% of project) can be done with the ENCPG support to make the gates & access to the manholes. Whereas the project goes back to 2008 original plan; the project now is coming before the ENCPG for an updated protection to avoid the back-up of the sewage going into the canyon area. The conception vote/motion is to vote in favor to support for the entire Project # 355106 and eventually gates 1 & 3 will come back to the ENCPG. Gates 1 & 3 will require the Fish & Wildlife Game Board approval and will have delays (20% of project). Patrick Ambrosio made motion, 2<sup>nd</sup> by Salimisha Logan; vote unanimously (8-0-0) by the ENCPG for the motion was passed.
- B. Verizon Wireless Communication Facility (WCF) 6508 Wunderlin Ave, Project # 355486 Presenter: Kerrigan Diehl, PlanCom, Inc.:
  Hand-outs were given with questions that were answered by public & the ENCP. Patrick Ambrosio made motion to approve and vote in favor of Project # 355486, 2nd by Steve Ward; vote of majority (5-3-0) by the ENCPG for the motion was passed.
- C. NW Village Creek Easement Vacation, Project # 354773 Presenter: Stephen Maduli Williams – This project was not discussed, presenter failed to attend.

### **10.CONTINUING BUSINESS:**

A. Election Committee Update

Presenters: Kathleen MacLeod and Patrick Ambrosio – Mr. Ambrosio presented new documents that will be used in future elections and will maintain the electronic records, so the future elections can be done with a standard and to begin in the month of November. Ms. Kathleen MacLeod came to assist in completing the ballot. Mr. Ken M. also assisted in validating the ballots to distribute them to qualified voters. There was a discussion from the public to add Ms. Leslie Dudley (Lincoln Park, 2 year term) and Mr. Barry (Brian) Pollard (At Large, 1 year term) to the ballot. It was further noted to correct the spelling of the name of Gail Reed to Gayle Reid as the Emerald Hills, 2 year term candidate on the ballot. After the ballot was finalized, Ms. Bucey stated that only one ballot would be needed to finalize the results of the election. The final count will be recorded with Ms. Bucey. With the new members-elect to the ENCPG, the next meeting will finalize the election process for the new ENCPG to vote for Chairperson, Secretary, & Recording Secretary, Ms. MacLeod has confirmed to ballot the month of April meeting. Additionally at the April meeting, it was charged to the election committee to confirm all of the current qualifying address information of all members of the new members-elect and the current members. The confirmation of address data will be done by all members showing their driver's license/identification; during the voting tabulation of the meeting.
