****Update regarding Duplication/Alteration of Project Plans:** The CPC Ad Hoc Committee meet last week along with Planning Staff Christine Rothman and a member of the media. Given CPC & certainly NPPC's reaction to the Oct 28, 2011 memo by Mary Wright, I was not optimistic, but sometimes surprises can happen. On December 21, 2011 I received the following email from Joe LaCava Chair of the CPC Ad Hoc Committee and worked directly with DSD & the City Attorney's office, his email is included directly below:

“Hi all,

I wanted to let you know that Christine Rothman contacted me this afternoon as a heads up that the city has moved quickly to adopt the language she offered at our Ad Hoc Committee meeting. Essentially it is a new sentence in the discretionary permit application form that states the owner/agent’s grants permission to the city and advisory bodies the right to make copies of plans and reports.

This change will show up in the online form as soon as the holiday schedule of the responsible DSD staff person permits. Further, all hard copies of applications with the old language on the third floor will be removed. Christine wasn’t sure how but there will be some notification of this change to applicant’s. I forgot to ask but will get back to Christine as to how/when the city will notify CPGs of this change.

This change was vetted through Kelly Broughton, Shannon Thomas and an attorney in the CAO’s Intellectual Property section.

The rapid movement was due to the city’s recognition that while the complaint was leveled at planning groups in fact the city itself did not have permission make copies. This response was to quickly rectify that situation going forward. I forgot to ask whether the city will make any attempts to get permission from applications already in play.

Christine explained that this language does in fact give cover to the planning groups as we had sought.

Shannon Thomas (City Attorney) will further discuss the hard and soft edges of copyright, fair use, and this new permission at our CPC meeting.

JANUARY 12, 2012: *What's So Special About University Heights? Defining Our Community Character*, Kristin Harms, University Heights Historical Society

University Heights is one of San Diego's oldest and most historic communities, which is one of the top five reasons people like living here. Kristin will provide a brief overview of the early history of UH, changes in our community's demographic profile since 1980, and highlights of two recent surveys among UH residents about our quality of life and community character.

FEBRUARY 9: 2012: *Community Planning: Balancing Individual Property Rights with Community Benefit*, Barry Hager, Esq.

Extensive and precious as they are, our property rights have never been - and are not now - absolute. Like most other rights, property rights are tempered by responsibilities. The U.S. Constitution does not give property owners the right to abuse the land or to use their property in a way that hurts others. To be sure, land-use restrictions must advance a public purpose, be fairly and reasonably applied, and leave property owners with an economically viable use of their land. When these standards are met, however, land use regulations will pass legal muster. Sensible land-use laws almost always enhance, rather than depress, property values. Barry will discuss the constitutional framework for property rights and community benefit, and a local real estate agent will describe the impact of location and related factors on property value.

MARCH 8, 2012: *Tools for Preserving Community Character: Historical Designation*

The City of San Diego recognizes the benefits of historical resource preservation to the community as well as to individual property owners. In addition to protecting the unique history, architecture, or character of a community, preservation efforts promote a sense of neighborhood pride, and stabilize or increase property values. Cathy will discuss the benefits of historic designation, financial incentives for owners of historical properties, and the process for historically designating individual properties as well as districts.

APRIL 12: 2012: *Tools for Preserving Community Character: Conservation Areas*, Marlon Pangilinan

Conservation areas are a planning tool that can be used to help protect a neighborhood's unique community character through architectural guidelines, development standards, and special zoning provisions. The precise nature of each Conservation Area is generally determined by the residents of a particular neighborhood, in conjunction with the local Planning Group and the City. Used successfully in other cities, San Diego is contemplating use of Conservation Areas. Marlon will provide an overview of the background, purpose, and process for using Conservation Areas and how they might be used in University Heights.

Citizen Research for Good Planning ~ Who Asks the Tough Questions?

A Best Practices Dialogue featuring Gabriel Metcalf, Executive Director of SPUR (San Francisco Planning & Urban Research Association)

The history of SPUR began in 1910 when a group of young city leaders came together to improve the quality of housing after the 1906 earthquake and fire as the San Francisco Housing Association ("SFHA") authored a hard-hitting report that led to the State Tenement House Act of 1911. In the 1940's, SFHA led the push to create San Francisco's Department of City Planning. In the 1950's, they pushed for revitalization of San Francisco as the Bay Area's central city, in an effort to curb suburban sprawl and channel growth in the urban core. Over the next five decades, SPUR built support for land use, transportation and investment strategies to support center-oriented growth and urban economic vitality.

SPUR has been involved with virtually every major planning decision in the city and plays the crucial role of uniting citizens to craft solutions to common problems. SPUR is a member-supported, nonprofit organization, and at our January Breakfast, Gabriel Metcalf, the current Executive Director, will discuss how citizen research supports good planning policy development in the San Francisco Bay area, and how SPUR is organized to do it effectively.

Bill Anderson, former Director of City Planning & Community Investments at the City of San Diego, and past C-3 President, will moderate a panel of San Diego organizations that are currently involved

in, or are initiating citizen planning research efforts such as Equinox, The San Diego Foundation and the Center for Urban Design & Economics (affiliated with UCSD). At the conclusion of Gabriel Metcalf's presentation, Mr. Anderson will ask the panel members to respond in kind to the following question: Is it needed here and are we prepared to do it?

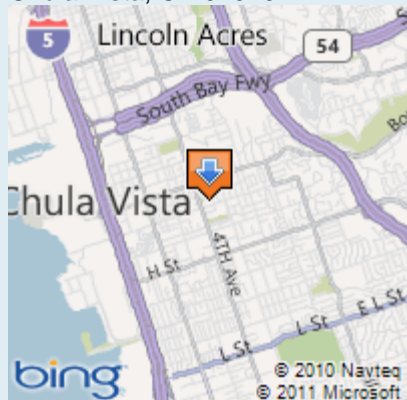
