DRAFT MEETING MINUTES: Monday, Feb. 4, 2013 – 6:00 p.m. North Park Recreational Center/Adult Center, 2719 Howard Ave.

I. Parliamentary Items

B. Approval of agenda

Motion: Approve tonight's agenda. Hill/ Granowitz 9-0-0

C. Approval of previous minutes:

Motion: Approve Oct 1, 2012 minutes, changing "mortgages" in item IV.A. to "rental rates". Bonn/Dye 8-0-1 (Steppke abstained due to absence)

<u>Motion</u>: Approve Jan 7, 2012 minutes Granowitz/Lewis 6-0-3 (Hill, Morrison, Bonn abstained due to absence)

D. Announcements:

Granowitz announced that Cecilia Gallardo, Dep. Dir. Planning Division (former DSD Dept.) will make presentation at the Feb 19 NPPC meeting. Granowitz also announced that the initial court ruling supports NPPC position on Irwin Jacobs Plaza de Panama project.

II. Non-agenda Public Comment (2 minutes each)

Steppke noted that there is a street vendor operating between Arizona St. and Hamilton, selling Mexican food and asked if this is legal. Audience member Kevin Clark of North Park Main Street indicated that this use is not allowed. Intervention will require Police to take action.

III. Action Items

A. AT&T – Boundary St. (Public Right of Way, 4375 1/3 Boundary St, Project No 226649)

Barry introduced project as a wireless community facility, noting that the Subcommittee has heard the item three times previously and voted against recommending approval. The proponent has redesigned the facility based on the Subcommittee's suggestions. At the last meeting, the Subcommittee supported the decreased height (lowered from 50 ft to 40 ft) but asked that AT&T meet with Roger Lewis to attempt to tie an upgraded design into the Redevelopment Project Area Committee's plans for this entryway to North Park. Three design options were presented. Each includes new lighted street bollards and stubbed out irrigation lines that can be later tapped into future development to avoid having to dig up the street to have landscaping irrigation brought in. **Option #1** is the original institutional tower-looking design. **Option #2** presents a new water tank design reflecting the iconic North Park Water Tower. The tank design includes tile installation, a Craftsman style "roof", and a backlit, brushed stainless steel cut-out North Park sign, and narrowed "legs". The Water tank is raised back to 46-48 ft. to accommodate the sign. **Option #3** is an improved version of the original basic tower design.

Lewis reported on his meetings with AT&T as well as with local public artist Lynn Schultz and architect Mike Singleton to obtain their professional input. The consensus from these meetings was that a cell tower cannot be "masked", therefore let's make it something iconic but abstract. There was general agreement by the Subcommittee tonight that the water tank design was a major improvement from the original submission. Steppke asked about the tile. AT&T architect indicated that it is a 6X6 pattern shown as charcoal grey, green & white, but colors are flexible. The material at the tower's base is genuine glossy tile; above must be fiberglass. Tile can be easily cleaned. AT&T is responsible for the tank's maintenance. The irrigation stubbing-off at north and south ends of the project prevent the need to dig through the street to import water. AT&T is installing its own water meter. Bonn asked about the signage. It is now shown on 2 sides versus the originally proposed 4. Dye asked that it be ensured that the North Park sign be readable from the freeway. Heights of the optional designs are: 40 ft for **option #1** and 47-48 for the water tower **option #3**. Barry noted that although the signage requires greater height, it is worth the tradeoff. Pyles praised AT&Ts responsiveness and indicated a preference for a greater incline on the lower roof of the water tank design. Granowitz expressed confidence in Lynn Schultze's artistic judgment. Members of the public expressed preference for the Water Tank design also. There was a consensus to definitely rule out design **option #1** (the design looking most like a prison guard tower) and to recommend **option #2**, the water tower design. Steppke requested blow-up photos of water tower design for the full board.

Motion: Recommend that the Board endorse design option #2 and the required CUP Roger/Lucky 8-3-0

B. T-Mobile, Trinity United CUP, 3030 Thorn St., (Project No. 292398)

The project replaces 5 existing antennas and associated equipment storage (3 cabinets) at the Trinity United church, 3030 Thorn St. It requires a CUP (process 3 – not 4, as stated on the agenda). The purpose of the project is simply to provide better reception. AT&T's permit expired 2011. The AT&T equipment will continue to be co-located with that of two other wireless providers. There will be no exterior or aesthetic changes, no exterior antennas. Barry asked if there were human activities below. T-Mobile representative did not know. A member of the public asked if there is radiation around the tower. Barry explained that this aspect of the project's review is governed exclusively by the FCC and that the project meets FCC standards. Local Planning has no control of this matter.

C. North Park Community Plan Update – Land Use Element:

Barry presented the maps prepared by Board Member Carl Moczydlowsky which were introduced to the Subcommittee at the Jan 2013 meeting. Subcommittee and public members discussed key issues that need to be addressed in the updated Land Use Plan, ranging from proposed densities to establishing design standards for defined geographic sectors.

Lewis left at 7:08 pm.
