- d. Request by Wayne Murphy that the approved project of Kensington Terrace incorporate design considerations into building. (See attached folder) And that a wooden, not wire, fence by used to screen construction process. Perhaps local artists could be encouraged to decorate. Mr. Murphy was also concerned about lack of attendance. Encouraged better communication about agenda items.
- e. Allard Jensen reported settlement with Heart of Kensington group over design of Kensington Terrace. Demolition almost complete. Starting on redesign based on settlement agreement. Moving his office into Kensington. Redesign will take about six months, he asked for community input and historical photos.

Some business owners want to overturn Historical Resources Board's decision to designate the sign as an historical resource.
