A regular meeting of Kensington Talmadge Planning Group (KTPG) was called to order by Chair Tom Hebrank on November 12, 2008 at 6:33pm in the Kensington Community Church located at 4773 Marlborough Ave., San Diego, CA 92116.

A motion was made by S. Pribyl, seconded by J. Tibbits, and unanimously approved to amend the agenda so the Secretary may present a written report of a potential vacancy due to successive absences.

MINUTES:

After a motion made by B. Coffin and seconded by J. Tibbits, the October 8, 2008 minutes were approved with changes by a vote of 10-0-2. D. Pfeifer & G. Greer abstained.

TREASURER'S REPORT

In the absence of Treasurer S. Hopwood, T. Hebrank presented the Treasurer report. As of October 31, 2008 there was \$738.16 in the KTPG bank account. During the month of October 2008, deposits consisted of \$169.00 in donations and zero disbursements.

PUBLIC COMMUNICATIONS

Chair T. Hebrank addresses the time constraints of the public communication portion of the agenda. He explained the purpose of KTPG and explained that folks are welcome to speak but should understand that KTPG may not have authority to address all concerns.

Various members of the public were present and conveyed the following:

- I. A. Jansen Update on Kensington Terrace. The land loan has been extended and the project size has been reduced. The current design consists of surface parking and a reduction in building square footage. Signs will be set up on the site with the intent of preleasing the building. A certain percentage of the building must be preleased to get a construction loan. He left a number of business cards for the community to contact him with any concerns. A number of questions arose including whether or not the residential component will be included in the new design, what, if any, aspect of the project is discretionary, how long with the gas station remediation take, whether or not the current design includes commercial condominiums, whether or not the building design includes any sustainable aspects.
- II. F. Lindahl Asked the board for time at next meeting to speak about the Hoover High School projects. The school is proposing stadium lighting over the football field, new buildings, and a new parking lot that will allow entrance on Highlands and exit onto Monroe (a historic corridor), amongst other things. The city has no purview over public school projects and it is being reviewed by the state. The community has not submitted an opposition letter to the state.
- III. T. Adam Inquired about which agency is responsible for filling in the tree wells that are along Adams Avenue. A member of community explains that Adams Avenue Business Association is responsible for filling in the tree wells. A discussion ensues and it is recommended that T. Adam contact Jim Schneider.
- IV. J. Kroft Inquired about the status of the Kensington sign. It was announced that this body doesn't manage the Kensington sign. A member of the Kensington Talmadge Community Association (KTCA), the body that does manage the Kensington sign, states that the sign was taken down for inspections and KTCA is still awaiting the results of the inspection.
- V. B. Coffin Requested that the utility undergrounding and purchasing microphones for KTPG be discussed by the board. It was announced that the individual who loans the microphones to KTPG is not present. He raised a concern over utility boxes being placed in front yards and other design flaws after visiting the Talmadge community. The Kensington community will be going through the design process and he is requested that an ad hoc subcommittee be formed and involved with the design process. General concern was raised about the aesthetics of the Talmadge undergrounding project and the impact of the undergrounding project on the character of the neighborhood.

- VI. G. Hanford Announced that the lamp posts were recently painted. He asked the community to refrain from taping signs on the lamp posts and screwing signs into the trees.
- VII. T. Hebrank Join the 6th Annual Kensington Tree Lighting Ceremony on Saturday December 13th at 4183 Adams Avenue.

After a motion made by T. Hebrank, and seconded by D. Moty the board unanimously appoints F. Lindahl as the KTPG liaison to the City Heights Redevelopment PAC.

 - i. Presentation and Q&A Session on Brown Act and Parliamentary Procedures M. V. KTPG Liaison Committee Reports - 1000 100

- a. Talmadge Maintenance Assessment District (TMAD) is presented by F. Lindahl.
 - i. The most recent meeting was the TMAD annual meeting. At the next TMAD meeting the board will pick officers.
 - ii. TMAD would like to redesign the entry into Talmage and create a gateway entrance.

- iii. It was noted that the TMAD did not get the required number of signatures to operate as a non-profit; thus, TMAD solicited signatures for a petition. The goal was to get 750 signed petitions and TMAD currently has 760 signatures. The City is currently reviewing the petition.
- iv. TMAD is revising final drawings to install over 220 lights that will cost \$1.1 million. The goal is to install the additional lights next year. As a part of the additional light project, TMAD is working to piggy back the current undergrounding project and install conduit for the proposed new lights.
- b. Community Planners Committee (CPC) presented by D. Moty.
 - i. Requested that telecom projects stay out of residential area, if possible.
 - ii. The Historic Resources Board (HRB) passed two motions to make appointments to HRB thereby filling some of current vacancies.
 - iii. M. Greene gave a presentation on administrative procedures.
- c. City Heights Redevelopment PAC (CHRPAC) presented by F. Lindahl.
- i. Marie Garner from city financing committee distributed handouts regarding a pedestrian master plan. The handouts were not provided to KTPG or the community but further information is available at:
