## Minutes of the April 25, 2011 Meeting

Motion made to approve the April Agenda as is: Jeff Perwin/Melinda Appling 2<sup>nd</sup>. Vote: 13-0-1. (Jorge Riquelme abstained). April meeting agenda approved.

Motion made to approve March meeting minutes with one correction in public comment, to change "UCSD" to USD Relay for Life event: Dixie Wilson/Melinda Appling 2<sup>nd</sup>. Vote: 14-0. March minutes approved.

### Agencies present at meeting:

- City Councilwoman Lorie Zapf shared her priorities for supporting public services such as keeping libraries, recreation centers, and public parks open in the Linda Vista area.
- Police Department representative, Officer David Surwillo, provided update on criminal activity.

Secretary – Kim Shannon nominated (Kathleen Morgen as backup), no other nominations, motion made by Doug Beckham to close nominations. Ballot vote conducted. Kim Shannon elected as Secretary to the LVPG.

Treasurer – Gail Cole, Ester McNulty, Tisha Rocha nominated. Gail Cole withdrew nomination, ballot vote conducted. Tisha Rocha elected as Treasurer to the LVPG.
