Water Quality Improvement Plan Consultation Committee Charter Los Peñasquitos, San Dieguito River and Mission Bay & La Jolla Watershed Management Areas

Purpose

The City of San Diego (City) and the Cities of Del Mar, Escondido, Poway and Solana Beach, the County of San Diego and Caltrans (Agencies) are working to protect water quality in the Los Peñasquitos, San Dieguito and Mission Bay & La Jolla Watersheds. The Agencies are required to convene "Consultation Committees" as part of their response to new storm water regulations. These Committees will assist the Agencies to create Water Quality Improvement Plans (WQIPs) for watersheds throughout the region. The City of San Diego will be convening the Committees in each of the three watershed areas it will be managing: Los Peñasquitos, San Dieguito River and Mission Bay & La Jolla.

The development of Water Quality Improvement Plans (WQIP) and the Committees are required by Provision B of San Diego Regional Water Quality Control Board Order Number R9-2013-0001, National Pollutant Discharge Elimination System (NPDES) Permit and Waste Discharge Requirements for Discharges from the Municipal Separate Storm Sewer System (MS4).

Committee Membership

At this time, the Agencies are seeking members to form Consultation Committees for the three watershed management areas being led by the City. The Agencies are specifically seeking Committee members with knowledge of the watershed area they wish to represent and at least general knowledge of the requirements and intent of the MS4 permit and associated water quality improvement opportunities.

The Committees will be comprised of members in the categories listed below. The Agencies may choose to add additional members at-large if there is sufficient interest in a particular watershed. Every effort will be made to ensure a balanced representation of interests and service categories on the committee.

- 1. One (1) required representative of the San Diego Water Board assigned by SDRWQCB.
- 2. One (1) required representative of the environmental community familiar with the water quality conditions of concern of the receiving waters in the watershed.
- 3. One (1) required representative of the development community familiar with the opportunities and constraints for implementing structural Best Management Practices (BMPs), retrofitting projects, and stream, channel or habitat rehabilitation projects in the watershed, preferably with relevant engineering, hydrology, and/or geomorphology experience in the watershed.
- 4. At-Large representative(s) familiar with the following issues and/or topics pertaining to the three watersheds: water quality issues in the watershed, opportunities and constraints for

implementing BMPs, retrofit projects, restoration projects, engineering, hydrology, geomorphology, or landscape architecture. These individuals may include, but not be limited to, residents of the watershed, staff members of the U.S. Environmental Protection Agency, and/or representatives of the environmental, business, academic, or development communities.

Committee Selection Process

The Agencies will publicize the availability of membership positions for each of the three Consultation Committees. The request for membership will be issued countywide. Membership solicitation notices will be sent out in September 2013 via email and will be posted on the Project Clean Water (www.projectcleanwater.org) and the City of San Diego's Storm Water Division (www.sandiego.gov/stormwater) websites. In addition, the Think Blue storm water pollution prevention program will announce the Committee application process through its social media outlets.

Those interested in membership will be asked to complete a brief statement of interest form which will be reviewed to ensure that members of the Committees will be capable of fulfilling the requirements and intent of the public participation process in the permit. If more than one person is interested in filling a specific category on the Committee, the Agencies will ask all those interested to determine among themselves who shall serve. The Agencies reserve the authority to appoint a specific individual from the pool of candidates if the applicants cannot reach a consensus among themselves. The Agencies may also select additional individuals for the At-Large category to help ensure a well-balanced committee.

Responsibilities

- 1. Committee members are expected to serve throughout the entire WQIP development process, which will begin in September 2013 and is expected to end in July 2015.
- 2. Public workshops: At least two (2) workshops will be held to obtain input from the public regarding the WQIP development process. The Agencies strongly encourage any Committee members chosen to serve to attend the workshops. The workshop schedule is posted at www.projectcleanwater.org.
- 3. Committee meetings: Up to five (5) meetings for each watershed group are currently anticipated. Committee members are expected to attend all scheduled meetings. These are expected to be up to 2 hours long. If a committee member is unable to attend a meeting, they will have an opportunity to provide written comments on the materials discussed according to the project schedule.
- 4. Committee members will review a total of three (3) Water Quality Improvement Plan drafts prepared. The Committee will provide input to the Agencies involved in water quality improvement efforts in the watershed. A schedule of meetings and deliverables (topics) is provided in Table 1.

5. Each committee member is expected to represent the general overall views of the area of representation. Individual or employer opinions and input should be qualified as such and offered following the more general input.

Committee Discussions and Deliberations

The Committee will provide input, advice, insight, suggestions and recommendations to the decision-making authorities for the watershed it serves. Discussions do not have to reach consensus. All input provided by the Committee will be public information.

3rd Party Facilitation

Workshops and Committee meetings will be facilitated and supported by a neutral third party to ensure all perspectives are heard throughout the process.

Ground Rules

The following ground rules apply to all Committee efforts:

- 1. All perspectives are welcomed and valued. Everyone is encouraged to share their views and disagreements shall be offered to the Committee in a constructive and respectful manner.
- 2. One person at a time will be invited to speak by the meeting facilitator. Interruptions should be avoided and inappropriate language and personal attacks are prohibited.
- 3. Time constraints will be honored by all Committee members. All those wishing to address approved agenda items will be offered a balanced opportunity to do so.
- 4. It is expected and required that all Committee members will treat each other with respect.

Media and External Communication

Though the Agencies cannot and will not restrict communication with media and others interested in the Water Quality Improvement Plan development process, they will work to ensure that the comments of individual members are not construed as being statements made by the Committee as a whole

Media

Committee members will be asked not to make public statements about the Committee's deliberations to the media that would tend to hamper constructive discussions. Committee members should also speak for themselves and not on behalf of other members or the Committee as a whole. Agencies' staff and consultants will also refrain from such statements about the Committee's deliberations.

Role and Responsibility of Public Outreach

Members will be asked to report back to the Committee regarding any public outreach that they participate in to keep their respective constituencies aware of the Committee's discussions and any issues that the constituencies have identified. City of San Diego staff will be available to provide assistance in this communication process, if desired.

Observers

Observers are welcome at Committee meetings. However, meetings are intended for the benefit of the Committee representatives to promote balanced, constructive interaction. Observers will be asked to refrain from commenting during the proceedings.

Workshops and Committee Meetings Schedule

Two (2) public workshops will be held for each watershed. The Committee will meet up to five (5) times: once before and potentially once after the 6-month and 16-month reports are submitted to the San Diego Regional Water Quality Control Board (SDRWQCB), and once prior to submitting the final Water Quality Improvement Plan to the SDRWQCB.
