Dear Mr. Horst:

This is regarding the posted speed limit on Hillery Drive between Greenford Drive and Black Mountain Road in the community of Mira Mesa. Local governments must follow the procedures set by the State of California when setting speed limits on public streets. The California Speed Trap Law (California Vehicle Code Section 40802) requires that the City survey the prevailing speeds on classified streets every seven years in order to keep our speed limits radar enforceable under the provisions of the law.

We have recently surveyed the above segment of Hillery Drive and the results of the study indicate that the existing posted speed limit of 30 miles per hour for the northbound and southbound directions of traffic can be lowered to 25 miles per hour and remain radar enforceable. Therefore, we will be changing the speed limit in both directions from 30 miles per hour to 25 miles per hour.

It is our practice to notify the community planning groups before changing the speed limits. If you have any questions concerning this action please contact David Chiang at (619) 533-3098.
