Information Items

- 1. There has been an application to the City by AT&T to replace three existing stadium light standards with three new light standards capable of supporting four antennas each (12 total) and a 15' by 20' block wall enclosure. Property is at the Adams Rec Center park at 3491 Adams Ave. The applicant is not yet ready to present their proposal to us.
- 2. City of San Diego has launched a public information campaign, "Lose the Roaditude!" encouraging everyone; motorists, bicyclists, and pedestrians to increase their awareness of common courtesy and traffic rules and to help curb anyone's aggressive on-road behaviors. "We consider people's willingness to ignore the rules of the road and act aggressive or negligent as "Roaditude."
