"Given that the Adams Avenue Recreation Center contains only a single ballfield, and this single ballfield is the only ballfield in the surrounding communities of Normal Heights, University Heights and Kensington of appropriate size for Little League Baseball play, and given that Mid-City Little League, which has been serving these communities since 1949, provides recreation activities for well over 150 boys & girls, the Normal Heights Community Planning Group supports Mid-City Little League's request to amend the Departmental Instruction (DI - 8.3, dated January 1, 2009) for the Adams Avenue Recreation Center ONLY, so that during the months of February 1 thru June 30, the Adult priority time does not start until 8 PM, in lieu of the 6 PM as outlined in the Directive."
