Re: PBPG Support for Vision Zero

Dear Kathleen:

The Pacific Beach Planning Group voted in favor to collaborate with Circulate San Diego and other partners to ask the City of San Diego to adopt Vision Zero and commit to the goal of eliminating all traffic-related deaths to zero by 2025.

San Diego was recently reported to be a city with one of the highest percentage of deaths for people walking among other cities in the U.S. On average, one person is seriously injured every day is seriously injured or killed on the road while walking, biking, or driving the streets of San Diego—many times in the same neighborhoods and on the same corridors. Vision Zero provides an opportunity to create quick, inexpensive projects on San Diego's most dangerous streets and capitalize on infrastructure efforts already underway. The City of San Diego can commit to Vision Zero by taking action on and linking a variety of plans already adopted or underway.

The Pacific Beach Planning Group joins Circulate San Diego and a coalition of business leaders, community members and neighborhood organizations to ask city leaders to adopt Vision Zero and eliminate traffic deaths by 2025.
