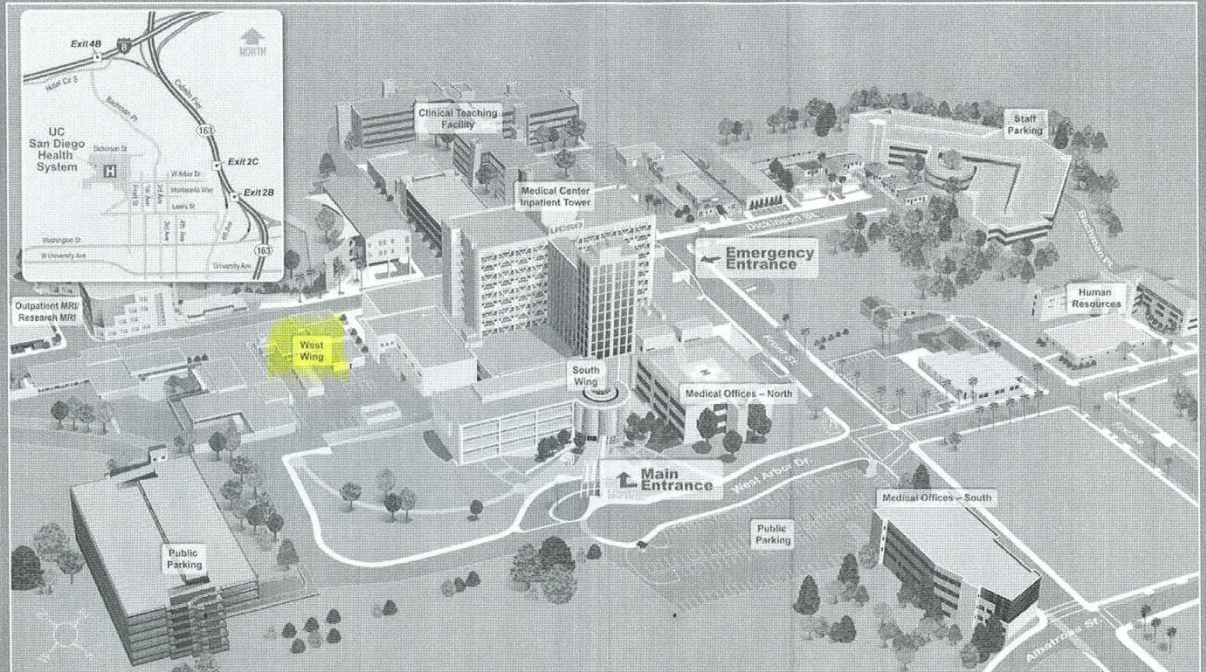
2. **2121 SAN DIEGO AVENUE (“OLD TOWN TRANSITIONAL HOUSING”) – Process Five Action Item**– Five Points/ Middletown -- Conditional Use Permit for Transitional Military Housing in an existing; 46,926 sq. ft. acre site at 2121 San Diego Avenue in the MCCPD CL-6 Zone; AAOZ; FAA Part 77, North Bay Redevelopment Area. *(A tentative agreement has been reach between the VA and Old Town Academy; the City Council continued the item until July 24, 2012; and requested Uptown Planners comment.)* **(7:00–7:45 p.m.)**
3. **VERMONT STREET ANGLE PARKING – Action Item** – Hillcrest – Proposal to place angle parking along the west side of Vermont Street between University Avenue and Robinson Street. Would add five additional parking space; Roy Dahl collected signatures of over 75% of the residential and commercial businesses owners on a petition in favor of the proposal. **(7:45-8:00 p.m.)**
