## **Historical Resources Board Presents Annual Awards**

**SAN DIEGO** – On Thursday, May 22, 2003, the City of San Diego Historical Resources Board presented its annual Awards of Excellence for Historic Preservation. The awards were given at the Board's regular monthly hearing in celebration of National Historic Preservation Week.

The Historical Resources Board annually gives special recognition to the people and projects that most significantly reflect the best of the year in historic preservation. This year awards in eight categories were presented to the following individuals:

- **SUSAN HECTOR, PH.D.**, in the category of **Archaeology** for her expertise and commitment to completing the San Dieguito River Valley Inventory of Archaeological Resources. An award for the same project was also presented to **LYNNE CHRISTENSON, PH.D.**, for her initiation of the project and grant, and support throughout the process.
- **KATHLEEN FLANIGAN**, in the category of **Individual Accomplishment** for her many years of dedication and material contributions to the field of historic preservation in San Diego.
- **ANNA TATAR**, City of San Diego Library Department, in the category of **Agency** for her cooperative spirit in supporting historical designation in conjunction with the expansion of the Ocean Beach Branch Library and other library projects.
- **JOHN FRY**, in the category of **History** for his dedication to increasing the body of knowledge about the history of Pacific Beach and sharing it with the public.
- **SHARON SMITH**, United States Marine Corps, in the category of **Cultural Landscape** for her cooperative spirit and dedication in ensuring the integrity of the historical Marine Corps Recruit Depot.

The City of San Diego's Historical Resources Board is a City Advisory Board comprised of 15 members appointed by the Mayor and confirmed by the City Council. Membership is required to represent the following disciplines: architecture, history, architectural history, archaeology and landscape architecture. Other disciplines that may be represented are law, real estate, engineering, general contracting, finance, planning or fine arts, and should reflect diverse neighborhood representation and have demonstrated a special interest in historical preservation.
