<u>Description</u>: Consider the designation of the property located at 2382 Via Capri Court as a historical resource.

<u>Today's Action</u>: Designate the property as a historical resource under adopted designation criteria, or do not designate.

<u>Staff Recommendation</u>: Designate the Robert and Lillian Orr House located at 2382 Via Capri Court as a historical resource with a period of significance of 1963 under HRB Criterion C.

Location: 2930 Marcy Avenue, 92113, Southeastern San Diego Community, Council District 8 (1289 5-E)

<u>Description</u>: Consider the designation of the property located at 2930 Marcy Avenue as a historical resource.

<u>Today's Action</u>: Designate the property as a historical resource under adopted designation criteria, or do not designate.

<u>Staff Recommendation</u>: Designate the Boys Club of San Diego located at 2930 Marcy Avenue as a historical resource with a period of significance of 1942 under HRB Criterion A. The designation is limited to the original 1942 structure and excludes all other structures and park land on the parcel.

Description: Consider the designation of the property located at 3112 Grape Street as a historical resource.

<u>Today's Action</u>: Designate the property as a historical resource under adopted designation criteria, or do not designate.

<u>Staff Recommendation</u>: Designate the William Chadwick Spec House #2 located at 3112 Grape Street as a historical resource with a period of significance of 1920 under HRB Criterion C. The designation excludes the 1950s altered detached garage at the rear of the property.
