The City of San Diego's NSP program is working actively toward the obligation of its grant award. In addition to the homebuyers assisted and properties acquired to date, the San Diego Housing Commission has a number of homebuyers approved and seeking properties or with executed purchase contracts under its NSP-1 activity; is working on completing due diligence for the purchase of a multi-unit property under its NSP-2A activity; and is in negotiations or escrow for additional home purchases under its NSP-2B activity. Additionally, the City plans to submit a technical amendment to its NSP Action Plan in April, pending approval by the San Diego City Council, to allow for-profit developers to participate in the NSP-2A activity to facilitate the obligation of its grant funds.

Please note that due to an unresolved system glitch in DRGR, the Plan Description and Recovery Needs sections above in this QPR are not showing the most recent narratives that have been entered into DRGR for the City of San Diego.
