SUBJECT : Appointment to the Housing Advisory & Appeals Board

It is my pleasure to appoint Susan Marshall to the Housing Advisory & Appeals Board, subject to your confirmation.

Susan Marshall CRS, GRI, PMN, SRES is a Real Estate Broker Associate for Prudential California Realty with more than 30 years experience in the real estate industry specializing in the resale of residential homes in San Diego and Northern California. With Prudential since 1994, Ms. Marshall previously served as a Real Estate Professional for Coldwell Banker in San Diego from 1985-1994, and a Real Estate Professional in Northern California from 1979-1981.

Ms. Marshall's success in the real estate industry led her to become involved in various real estate associations including Buyer and Seller Relocation Services, California Association of Realtors, National Association of Realtors, Residential Sales Council, and Women's Council of Realtors. She has been a member of the San Diego Association for more than 20 years, and served as President of the Association in 2002.
