Dear City Council,

I am writing to ask you to rescind your approval of One Paseo. This is not because I think the Planning Board's are great (they are not perfect and need substantial reform themselves). This is not because I like or support Sheri Lightner (I do not). THIS IS BECAUSE I LIVE IN CARMEL VALLEY AND THIS PROJECT IS TOO BIG AND 3 TIMES THE COMMUNITY PLAN. That is the reason I don't support it and a majority in my community do not support it.

There have been a lot of lies spun by Kilroy. One is that people support the project (in reality, very few locals outside the industry do). Another is that Donahue-Schribner is some out of town developer financing the opposition for selfish reasons. This is not true. Elizabeth Scribner is on-site at Del Mar Highlands Center, a local herself, and I have found her company to be the only responsible shopping center developer in the region. She took so much public comment when they were re-imagining Del Mar Highlands, and called me personally when I was upset that Red Robin lost their lease. These are the real members of the community, not Kilroy.

Thousands of local residents and tens of thousands of San Diegans have raised serious concerns about the project. Four community planning boards rejected One Paseo and now more are speaking out about the dangerous precedent its approval set for development in the City.

My family and I look forward to development of the property slated for One Paseo, as we prefer to shop and go out to eat near our home. However, I am extremely concerned about the size of the project because the area cannot possibly handle the amount of additional traffic it will produce. I have attended three community planning meetings and heard about Kilory's offer to pay for traffic mitigation, including the installation of "smart lights". While that sounds nice, it is a false promise, because no matter what is done to Del Mar Heights Road and El Camino Real to move traffic through more efficiently, the rate limiting factor is always going to be the traffic on the I-5 and Hwy 56 freeways. On a daily basis, traffic on the I-5 starts backing up at Del Mar Heights Road or before; therefore, no matter what is done to move cars easily to the freeway, they will just end up crowding the roadway waiting to get on the freeway.

Another important consideration is that there are three major high schools on Del Mar Heights road that feed hundreds if not thousands of new drivers on that roadway every weekday. Adding traffic the surrounding roadways is going to create a dangerous situation.

If the City Council approves One Paseo in its current form, it will be condemning the residents, as well as the One Paseo customers/residents, to an untenable situation that council members will have to answer for in the future.
