Before all of the crazy hype that is going on now, I had a call ask for me by name, asking if I'd received the one paseo brochure and if I'd support the project. My 10 second review of the impressive brochure yielded "big. Where do we park? . I iterated that in response.

Rather than politely tell me more, they hung up.

That was my first red flag.

Please know many Carmel Valley residents resent the big business cramming us so tightly that it is sometimes hard to simply go to the grocery store because it is so difficult to park. It takes longer to park and negotiate traffic than it does to shop.

Thank you for your time. I agree with the form letter so am tailing my note with it.
