DUMPING OF TRASH AND REFUSE

WITHIN THE CITY.

As requested by Your Honorable Body in Resolution No. 66839, the Planning Department has made a survey of existing trash and rubbish dumps within the city limits.

There are several ordinances pertaining to the subject. Ordinance No. 7691 prohibits dumping of refuse on public streets, alleys or other public places, or upon any premises in the city, and provides a penalty of a \$200 fine or 100 days in jail.

Ordinance No. 7791 requires any person, firm, or corporation gathering, collecting, or hauling city refuse to obtain a permit from the Health Department. It also prohibits the dumping of city refuse or waste matter in any water or waterways, within the city. The penalty is the same as in ordinance No. 7691.

Ordinance No. 11708 prohibits dumping or throwing of rubbish of any kind upon any lot, or tract of land, or upon any street, alley, lane, court, or place or sidewalk within the city, without the written permission of the City Council. Owners are prohibited from placing or allowing to remain on the premises any such rubbish without the Council's written permission. The penalty for violation is a \$50 fine or 60 days in jail.

In addition to the above ordinances, the zoning ordinances prohibit the use of much of the land in the City for such things as trash dumps. Penalty for violations of these ordinances is a maximum of \$500 fine or 6 months in jail.

In the following report is included a map showing the location of a number of the disposal places. Supplementing this is a series of pictures showing the condition of the property. Additional data is also presented giving the names of the property owners, the legal description of the property, the zone, and date of zone ordinance, and other pertinent data.

In general there are two classes of refuse dumps. One type, of which there are only a few, has an attendant present who sorts the material and salvages certain portions of it, and burns some. The other type, which is most prevalent, is caused by the haphazard dumping of waste material such as cans, paper, boxes, wrecked automobiles, bodies, tree trimmings, spoiled fruit and vegetables, etc.


Some dumping is done with the idea of filling canyons or holes to make usable land. Some is done only to dispose of refuse at the most convenient place, with little regard to the appearances or the effect upon surrounding property values.









C O N C L U S I O N

Certain basic facts are evident from an examination of the foregoing data. First, the disposal of rubbish is not being handled in a manner consistent with San Diego's best interests. There are far too many places in the City where refuse is dumped. Most of these places should be closed to future dumping and the property cleaned up. To do this, it may be necessary to make arrests. The Police Department and the general public can assist in apprehension of any person dumping in unauthorized places.

A few places should be selected and authorized for dumping. These places might include certain existing locations, but in any event, they should be screened from view as much as possible, either by fences or planting of shrubbery or trees. Dumping should take place in daylight hours and burning at night. No charge should be made to dump rubbish. A responsible person should be in charge of each dump. At regular intervals the filled material should be covered with a layer of earth to obliterate the evidence of the fill. The area should be kept free from rats and other disease-bearing vermin.




Looking north on Texas St. toward Adams Ave. bridge.






View from Adams Ave. bridge directly over dump.








General view of City dump at foot of 8th St.
taken from 8th and Imperial Ave.








