**DESIGNATED POSITIONS, DUTIES AND CATEGORIES**

<b><u>ADMINISTRATION</u></b>		
Program Manager	Administration of the Office of Homeland Security. Approves or recommends policy and financial decisions, provides departmental supervision, interfaces with City Council and Committees, and approves contracts.	1
<b><u>FINANCE AND RECOVERY</u></b>		
Supervising Homeland Security Coordinator	Supervises and oversees the Finance and Recovery Section of Homeland Security, recommends financial decisions, oversees grant program, coordinates projects, and interfaces with committees and task forces.	2
<b><u>PREPAREDNESS AND RESPONSE</u></b>		
Supervising Homeland Security Coordinator	Supervises and oversees the Preparedness and Response Section of Homeland Security, recommends financial decisions, oversees response program, coordinates projects, and interfaces with committees and task forces.	2
<b><u>CONSULTANTS</u></b>		
Consultant	Performs consultant services for the Office of Homeland Security.	3

**Appendix B  
Disclosure Categories**

**Category 1**

Investments and business positions in any business entity either located in or doing business with the City of San Diego.

Income and gifts from sources located in or doing business with the City of San Diego.

Interest in real property located in the City of San Diego, including property located within a two-mile radius of any property owned or used by the City.

**Category 2**

Investments and business positions in any firm or business entity that supplies goods or services to the City, that is a tenant of the City, that is an adverse party to the City in a legal proceeding, or is granted authority by the City to use City facilities.

Income and gifts from any person or business entity that supplies goods or services to the City, that is a tenant of the City, that is an adverse party to the City in a legal proceeding, or is granted authority by the City to use City facilities.

Interest in real property located in the City of San Diego, including property located within a two-mile radius of any property owned or used by the City.

**Category 3**

Consultants shall be included in the list of designated employees and shall disclose pursuant to the broadest disclosure category in the code subject to the following limitation:

The Program Manager of Homeland Security or designated authority may determine in writing that a particular consultant, although a "designated position," is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements described in this section. Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The Program Manager of Homeland Security or designated authority's determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code.
