Reported out in Open Session on July 25, 2006, by Karen Heumann, Assistant City Attorney:  
The City Council, yesterday, July 24th, voted 8-0 in Closed Session to authorize a settlement in the case of *City of San Diego v. Loraine Chapin*, which was Closed Session Item 7, which is pending in San Diego superior court. The motion was by Council President Peters with a second by Councilmember Atkins. The complaint sought to void the 1998 MOU and related resolutions and ordinances that created separate legal counsel for the board of SDCERS. On or about

September 12th, 2006, the City Council will consider eliminating those positions and returning as SDCERS legal counsel to the City Attorney's Office. Under the terms of the settlement the City will pay Ms. Chapin, \$74, 810, and the City will dismiss the lawsuit without prejudice. The City also agrees that it has no present intention to re-file the case.
