The City Council voted today on CS Item-1, *McGuigan v. City of San Diego*, San Diego Superior Court Case No. GIC 849883, to authorize settlement of attorney fees. The City of San Diego will pay Attorney Michael Conger \$1.6 million in three annual installments over a three-year period. These payments will be credited against the City's obligation under the Settlement Agreement and Judgment to pay an additional \$73 million to SDCERS. The motion by Councilmember Madaffer – second by Councilmember Frye. Motion passed 5 to 0 with Council President Peters and Councilmembers Maienschein and Hueso absent.
