Today, the City Council voted in Closed Session on Item CS-1, *In The Matter of: Natural Gas Anti-Trust Cases I, II, III & IV (Relating to City of San Diego v. Sempra, et al.)* to approve the settlement of the consolidated cases with Sempra for \$2.5M. The City's share is under \$100,000. The final amount will be established after tabulation of costs-to-date and pro-ration of the balance among the Plaintiffs. The motion was made by Council President Pro Tem Madaffer and the second by Council President Peters. The motion passed 7 to 0 with Councilmember Hueso absent.

**REPORT OUT FOR PRIOR CLOSED SESSION MEETING MADE IN OPEN SESSION**

Item CS-2: *Latoshia Otis v. City of San Diego, et al.*  
San Diego Superior Court Case No. GIC 879100

On November 20, 2007, the City Council voted in Closed Session on Item CS-2, *Latoshia Otis v. City of San Diego, et al.*, San Diego Superior Court Case No. GIC 879100, to authorize a settlement which requires the City to pay the Plaintiff \$75,000, place the Plaintiff in a permanent Utility 1 position with the Streets Division should such a position come open during the current fiscal year, and allow the Plaintiff 30 days unpaid leave. As part of the settlement agreement, co-defendants McKeaver and Murphy have waived their right to seek indemnification from the City for their attorneys' fees and costs incurred in the defense of the lawsuit. The settlement agreement also

requires the City to pay the mediator for the unpaid balance for mediation services totaling \$682.50. The matter was recently settled and is now reportable. The motion was made by Council President Pro Tem Young and seconded by Councilmember Madaffer. The item passed unanimously 8 to 0.
